MATERIALS AND SERVICES FOR THE EVENT**

RECOMMENDATION

1. Approve the Disability Awareness Day scheduled on October 4, 2018 as a City Council sponsored Special Event and approve the expenditure of funds.
2. Approve and accept donations from various individuals, businesses or community groups to support the event.
3. Place the item on the September 11, 2018 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Disability Awareness Day will be held on October 4, 2018 at San Jose City Hall and sponsored by Councilmember Jones. This special event builds an integrated community by empowering people with differing abilities to overcome barriers through access to resources, education, and employment opportunities while increasing the appreciation of people with differing abilities by highlighting their talents and gifts. The event is free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Jones will report any cash or in-kind donations received for the
