RECOMMENDATION

1. Approve the Shred-a-thon and E-Waste Collection scheduled on Saturday, September 22, 2018 as a City Council sponsored Special Event and approve the expenditure of funds.
2. Approve and accept donations from various individuals, businesses or community groups to support the event.
3. Place the item on the September 11, 2018 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Shred-a-thon and E-Waste Collection will be held on September 22, 2018 at 3164 Olsen Drive and sponsored by Councilmember Jones. This special event encourages residents to protect their identities by securely shredding personal documents and safely disposing of e-waste onsite, with services provided by Shred It Document Services and GreenMouse Recycling. The event is free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Jones will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1).
