#### **WORK PLAN**

Fostering Neighborhood Associations: Develop a process for developing and coaching successful Neighborhood Associations to significantly increase coverage throughout the city. This will be done by working with residents to form new Associations, working with existing Associations to get actively involved with District Leadership Councils, and the Neighborhood Commission to be actively involved with the District Leadership Councils.

**Roadshow & Leadership Conference:** Create a "Roadshow" platform, leadership training session(s), and an integrated communication platform, a portion of which will be fostered through the Smart City program.

#### **DEVELOP WORKING PROCESS**

<u>Fostering Neighborhood Associations:</u> In starting a Neighborhoods Association, it was discussed by District Leaders that the first step in effective communication is providing and creating a Fostering Neighborhoods Association (FNA) and Neighborhood Tool Kit, which the ad hoc developed in this year.

<u>Working Process:</u> How the ad hoc develop a process for developing and coaching successful Neighborhood Associations. The Neighborhood Associations and District Leadership Councils agreed that a Neighborhood Tool Box was needed as a starting point. So the ad hoc put together the first Neighborhood Tool Kit to included:

- 1. Board of Director's Responsibilities
- 2. Sample By-Laws

## **Next steps:**

- Creating a foundation for the FNA within the VOC Roadshow communication platform.
- Making the Neighborhood Tool Kit in three languages: English, Spanish and Vietnamese.
- Working with all District Leadership Councils to distribution and teaching on the introduction to Neighborhoods Tool Kit.

<u>VOC Roadshow:</u> In creating and developing a working process the Commission needed a brand name so city residents could identify with the Neighborhoods Commission. The ad hoc has picked the phrase VOC Roadshow and we will present topics residents care about like illegal fireworks and illegal dumping prevention.

*Opening Remarks:* Welcoming District Leaders, Chair & Vice Chair of your Leadership Council, Councilmember, and Neighborhood Commissioners. Giving (each person?) a couple mins to speak on updates to the community.

What is the Neighborhood Commission? The presentation on What is the Neighborhood Commission will always be at the beginning of the VOC Roadshow communication platform.

Special Guest Speakers: With preapproval from the Neighborhood Commission, add guest speakers and slides for their additional topic(s) to the Roadshow presentation prior to the event.

VOC Roadshow Presents: The ad hoc would feature one championing project and put it center stage for the VOC Roadshow.

Fostering Neighborhood Associations: Will be a part of the VOC Roadshow communication platform. Fostering Neighborhood Associations (FNA) will provide different segments pertaining to FNA.

Q&A: Take questions that the residents have. Not limited to the topics discussed with the VOC Roadshow communication platform.

Closing Remarks: Closing Councilmember, Neighborhood Commissioners, Chair & Vice Chair of your Leadership Council. Giving couple mins to each to speak.

<u>Next steps:</u> To find one championing project from the work plan 2018 thru 2019 for VOC Roadshow Presents. Implementing FNA to the VOC Roadshow communication platform. The next segment pertaining to FNA distribution and teaching on the Introduction to Neighborhoods Tool Kit.

## **OUTREACH**

<u>Fostering Neighborhood Associations:</u> No outreach is necessary for FNA. This has been absorbed by the Voice of the Community (VOC) Roadshow communication platform.

**VOC Roadshow:** The First Neighborhood Commission Road Show was a great success in D2 on February 28, 2018 at the Southside Community Center. The topics were: What is the Neighborhoods Commission, starting a Neighborhoods Association, and Illegal Fireworks & Illegal Dumping. D2 Chief of Staff Vanessa Sandoval for Councilmember Sergio Jimenez and Committee members engaged with the public during the Q & A section. I would like to thank Councilmember Sergio Jimenez on behalf of Neighborhood Commission for his ongoing support.

Outreach is a vital part of having a working relationship between Councilmember and Neighborhood Commissioners and it is a corner stone to the success for the VOC Roadshow. This helps the ad hoc VOC Roadshow book the event and advertise though the Councilmember's newsletter. The ad hoc would like input from the Councilmember of that district about the Special Guest Speaker to ensure the right person/organization is selected for the district. The Special Guest Speaker needs to be approved by the Neighborhood Commission at least one-month prior to the event.

The Commission developed a short, colorful "branded" marketing tool, called a "snippet" which allows for easy, rapid communication via email or approved social media platforms. We recommend continued use and expansion of this tool.
