RECOMMENDATION

Accept this semi-annual Open Government Report on posting of public calendars, public record request data, and data regarding posting of agendas and minutes of the City Council and decision-making bodies.

BACKGROUND

On August 21, 2007, the City Council approved a Rules and Open Government Committee recommendation requiring the Mayor and Council, Chiefs of Staff of the Mayor and Council offices, and certain Council Appointees to maintain calendars. Calendar entries are required to include, at minimum, all City-related appointments, including regular and special City Council meetings, public events or speaking engagements, meetings with developers, meetings with consultants, meetings with lobbyists, regional meetings and meetings of subcommittees or task forces. For each City-related appointment, the name(s), title(s), affiliated organization(s) and a general statement of the issues to be discussed should be included in the calendar entry. The calendar posting requirements were reaffirmed by the City Council at the August 26, 2014 City Council meeting when the Consolidated Open Government and Ethics Provisions was approved.

The Administration prepares a compliance review twice a year covering the January-June and July-December periods and reports the results to the Rules and Open Government Committee within a month following the close of the reporting period.

On August 22, 2017, the City Council approved a recommendation from the City Auditor, which was included in the 2017 Audit of Open Government, to add additional information about the status of open government, including public records requests and data regarding posting of agendas and minutes of the City Council and decision-making bodies in this semi-annual report. Due to staffing transitions after the retirement of the previous Open Government Manager, the January 17, 2018 report did not include the City Auditor's recommendations. This report includes the City Auditor's recommendations for the first time and will continue to have similar categories on each Open Government Report moving forward.

ANALYSIS

Calendar Posting Compliance

The most recent calendar compliance review (Appendix A) was completed on July 31, 2018, for the period of January 1, 2018 through June 30, 2018. The review shows an average of 94% compliance. The asterisk on the compliance check log indicates weeks where the information posted on the calendar was insufficient to determine compliance. Based upon the difficulties in evaluating the data, no rating was made for compliance on the content of the calendar entries. Issues noted include:

- Postings appeared to only include standing meetings. Entries were replicated each week with little to no variation in the postings.
- Postings did not contain enough information to determine if the meeting met the criteria where the minimum details were required.
- Postings were not published on time.

Public Record Requests

For the period of January 1, 2018 through June 30, 2018, the City completed an estimated 2,746 Public Records Act requests (Appendix B). The data for days to respond to requests was not available at the time of writing this memorandum. Historically, each department did not record the data due to staff transitions, training, and various factors. There has been an increase in the number of requests for "all communications" including emails, text messages, and social media postings. During this period, no appeals were made to the Open Government Manager. In addition, moving forward starting August 2018, all Department Coordinators are required to track their Public Records Act requests. The July through December 2018 Open Government Report for the period July 1, 2018 through December 31, 2018, will reflect the number of processed requests and the data on days to respond to those requests.

Posting of Agendas and Minutes

For the period of January 1, 2018 through June 30, 2018, the breakdown (Appendix C) of the posting of agendas for the City Council, Council Committee, and decision-making bodies with the following average of compliance in meeting Sunshine Ordinance and Brown Act regulations:

• City Council: 100%

• Council Committee: 100%

• Decision-Making Bodies: 100%

Synopsis and minutes completion rates showed below are for the period of January 1, 2018 through June 30, 2018 The following is the average of compliance in meeting Sunshine Ordinance regulations:

• City Council Synopsis: 97% completed

• City Council Minutes: 0% completed

• Council Committee Minutes: 18% completed

• Decision-Making Bodies Minutes: 96% completed

Decision-Making Bodies includes the Appeals Hearing Board, Board of Fair Campaign and Political Practices, Civil Service Commission, Deferred Compensation Advisory Committee, Planning Commission, Federated City Employees' Retirement Plan Board of Administration, and Police and Fire Retirement Plan Board of Administration. The Salary Setting Commission did not meet during this time. The Voluntary Employees Beneficiary Association Advisory Committee is set to be established at the September 11, 2018 City Council meeting and hold its first meeting in October.
