SUBJECT: UPDATE TO THE AUGUST – DECEMBER 2018 WORK PLAN FOR THE COMMUNITY AND ECONOMIC DEVELOPMENT COMMITTEE

RECOMMENDATION

Amend the August – December 2018 Community and Economic Development Committee Work Plan to add the following item to the October 22, 2018 Agenda:

Housing and Community Development Commission's FY 2018-19 Workplan (Housing) Purpose: Approve the Housing and Community Development Commission's FY 2017-18 Annual Accomplishments and its FY 2018-19 Workplan.

BACKGROUND

In FY 2010-11, as part of the efforts to streamline staff support of boards and commissions, City Council began requiring each of the City's Boards and Commissions to submit an annual workplan and annual report for review and approval. Both documents must be submitted in the format determined by the City Clerk.

The workplan and annual report provide the City Council with clear detail about Board and Commission activity. The workplan identifies specific priorities, allowing direct and concise direction to the members of the bodies, while managing the time of the City support staff; the annual report documents implementation of the previous year's workplan.

Items on the workplan must clearly align to the Commission's purpose, and be consistent with City policies including Policy 0-4. Once approved, Boards and Commissions may not engage in activities that are not on the workplan without approval of the modified workplan.

In the previous years, the Rules and Open Government Committee approved the Housing and Community Development Commission's annual reports and workplans.
