## **RECOMMENDATION**

#### **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Coffee Hours will be held on October 18th<sup>2</sup> 2018, November 1<sup>st</sup> 2018, November 15th, 2018 and November 29<sup>th</sup>, 2018 at San Felipe Le Boulanger, Capitol and Tully Starbucks, Aborn and White Starbucks, and the Village Square Library and sponsored by Councilmember Arenas. This special event is an opportunity for the public to meet and stop by for a conversation with the councilmember. The event is free and open to the public.

## ANALYSIS
