I founded a Toastmasters club within my office in 2012, and served as the President of the club from June 2012 - May 2013, and January 2014 - June 2014. I also served as Vice President of Education for the club from June 2014 - December 2014. As President, I managed the Executive Committee, set agendas and ran officer meetings, and oversaw club business and goals. As a club officer, I helped guide the club to acheive "Select Distinguished Club" status in 2013, 2014, and 2015. I have also served in an advisory capacity to the Friends of the Willow Glen Children's Theatre. While never formally holding a position on the Board, I assisted this group of parent volunteers in forming a non-profit corporation to support this program, which is run through the City of San Jose Parks, Recreation, and Neighborhood Services. I attended Board meetings and reported on requirements for non-profit status, and updated the Board throughout the process of applying for and obtaining non-profit status. I also assisted the group in fundraising activities, and developing policies for a scholarship program run by the Friends of the Willow Glen Children's Theatre to program participants.

In my position as a Trial Attorney with the U.S. Departent of Housing and Urban Development, I defend the Agency in Equal Employment Opportunity (EEO) Complaints, representing the Agency in all phases of discovery and hearing. I provide training to supervisors on employment and labor topics, including best practices in communication, best practices in hiring, FMLA legal obligations, EEO Laws and Processes, and Reasonable Accommodations. I have assisted management in labor disputes and in the negotiation and development of a region-wide collective bargaining agreement. I work in partnership with HR staff to administer and review employee displinary actions. I represent the Agency in labor matters before various administrative bodies, and in arbitration. In my position with CSz San Jose, I assisted in the development of a Code of Conduct and Grievance Reporting Procedure. I serve on the Conduct Committee, which handles complaints from CSz employees or community members, assisting to create an environment that promotes diversity and inclusion, free from discrimination.

What is your understanding of the purpose of the Commission?

As I understand it the Commission has two main purposes: (1) to review and make recommendations to the City Council on civil service rules, and (2) to hear appeals from City employees on certain personnel decisions. As such, the Commission plays an important role within the City of San Jose in ensuring that employment policies and practices are nondiscriminatory and administered in accordance with laws and regulations.

Please list three issues facing the City that you feel the Commission should address.

One major issue that we all are facing is a lack of confidence in our governmental institutions. There is a further issue of concerns that past strides toward equal opportunities and nondiscrimination have been erased, and that discriminatory views and actions are accepted without consequences. This is a concern in the private sector as well as the public sector. As the Capital of Silicon Valley, and a community that celebrates diversity, the City of San Jose is particularly well-suited to be a lodestar for doing what is right, treating employees and all people with dignity and equality, regardless of their protected classes. The Civil Service Commission plays an important role in reviewing both the City's policies, as well as its actions to ensure that the City lives up to the high standards expected by the residents, and protecting the rights of City employees. Another related issue is an aging workforce and increasing obligations of employers to accommodate employees with health issues under the FMLA and ADA. Sometimes perceived employment performance problems are actually related to a medical issue, and as an employer, the City must be mindful of employees' rights to take leave or request reasonable accommodations when the employee is dealing with a serious medical condition or disability that is affecting his/her performance in the workforce. The Commission should be mindful of these protections for employees and be aware of the potential liability for the City if these laws are ignored or misapplied. Although employees with a disability do not and should not receive a "free pass" for all performance problems, as an attorney practicing labor and employment law, I have seen in my experience, particularly as it relates to leave and attendance issues, that very often a supervisor or manager has not been properly trained in FMLA and ADA obligations, particularly as it relates to recognizing requests for reasonable accommodation. Finally, one issue that I think the Commission is particularly well positioned to address is employee morale and trust between management and the employees. As an experienced mediator, I have found that so often conflict is the result of a breakdown in communication. As a labor and employment attorney, I have seen that lack of transparency from managment can also be a contributing factor to discrimination complaints, and that lack of communication regarding decision making can lead employees to believe that discriminatory motives are at play. I believe that the Civil Service Commission has a role to play in increasing the communication between management and the employees when providing employees an opportunity to have their grievances heard by an impartial body.
