Subject: D2 Special Events

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Dumpster Days will be held at the following dates and times:

- October 20, 2018- Oak Grove Neighborhood, on Hayes Ave between Apple Blossom Dr. and Garrison Dr.
- November 10, 2018- Cottle to Lean Neighborhood on Calpine Dr. in front of Anderson Elementary School.
- November 17, 2018- Edenvale, Great Oaks Neighborhood on Giusti Dr. adjacent to Great Oaks Park.
- December 8, 2018- Havens, Riverview Neighborhoods on Skyway Dr. between Stonyhaven Way and Houndshaven Way

Councilmember Jimenez is the sponsor of these dumpster day events. These special events will allow residents to discard unwanted items legally and safely. The events are free and open to the public.

### **ANALYSIS**

Approval by the City Council of the events will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Jimenez will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 2, City departments and the Office of the City Clerk to proceed with the events. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.


