RECOMMENDATION

ANALYSIS

The Mayor and the City Manager are responsible for developing the City Council Meeting Schedule. This request covers the period January-June 2019.

Over the years, both Council and staff have expressed how difficult it is to prepare for Council meetings when there is a holiday either before or after the Council meeting. The Administration recommends, as it has in the past, cancellation of Council meetings when there is a holiday (Attachment A). The proposed schedule contains the cancellation of five meetings: January 1, January 22, February 19, April 2 and May 28. The schedule also contains two evening sessions per month. Per Council direction, the second evening session on an as needed basis. The Administration will recommend cancellation of evenings when they are not needed.

The Administration has developed a tentative schedule of Study Session dates (Attachment B) to facilitate calendaring for Council Members and the Mayor. As study session topics are developed and set for the dates in the attachment, they will be brought to the to the Rules & Open Government Committee for approval.
