

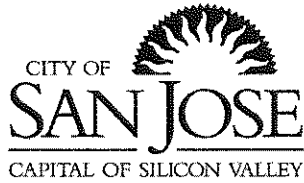
RECOMMENDATION:

RECOMMENDATION

1. Approve the District 6 Faith Leaders Luncheon scheduled on November 8, 2018 as a City Council sponsored Special Event and approve the expenditure of funds.
2. Approve and accept donations from various individuals, businesses or community groups to support the event.
3. Place the item on the November 27, 2018 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

District 6 Faith Leaders Luncheon was held on November 8, 2018 at Center of Spiritual Living, 1195 Clark Street and sponsored by Councilmember Dev Davis. This special non-denominational community event united District 6 faith leaders for a luncheon to start new relationships and thank community organizations for their service to the City of San Jose. The event is free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Dev Davis will report any cash or in-kind donations received for
