

BACKGROUND

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

In conjunction with presenting a proclamation at the October 2, 2018 City Council meeting to recognize the month of October as Domestic Violence Awareness Month, the Rotunda and the Tower lights were displayed in purple from October 1-5, 2018. On October 2, 2018, Vice Mayor Magdalena Carrasco held Light up the Night for Domestic Violence in the Rotunda to raise awareness of the impact of domestic violence in the City of San José. Event supplies and food were purchased for this special event to help encourage community engagement on this important issue. The event was free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Vice Mayor Magdalena Carrasco will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 5, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
