WHEREAS, the 4349 San Felipe Road General Plan Amendment (the "Project") analyzed under the Initial Study/Negative Declaration consists of a General Plan Amendment request to change the General Plan/Land Use Transportation Diagram Designation (land use designation) from Rural Residential to three land use designations consisting of about 0.37 acre of Rural Residential in the center of the site; about 0.43 acre of Open Space, Parklands and Habitat on the western portion of the site encompassing Thompson Creek; and about 0.19 acre of Neighborhood/Community Commercial on the eastern portion of the site fronting San Felipe Road, all on a 1.0 gross acre site (Assessor's Parcel Numbers 676-36-007) in San José, California; and

WHEREAS, the Initial Study/Negative Declaration concluded that implementation of the Project would not result in any significant effects on the environment; and
