I want to continue as a member of the HCDC because I am not only one of the most knowledgeable members, but I am passionately committed to the issues about which the HCDC is charged to make recommendations. Not only do I faithfully attend meetings, but I am "on the ground" in the City talking to and working with the homeless, folks concerned with affordable housing, and residents equally concerned about the preservation of mobilehome parks in San Jose. When I first applied, I listed as some of my specific objectives:

- To help in this consolidation process instead of trying to sink a ship that has already sailed. (refers to the consolidation of the MAC, the ARC and the old HCDC
- To bring Mobilehome issues into the broader rubric of Housing instead of ghettoizing them
- To serve as a voice of moderation within the context of interests that are frequently seen as adversarial: landlord versus tenant, resident versus Park owner.

- To contribute my vast, years old knowledge of these issues to the new Commission.
- To speak for the Seniors, people living with HIV/AIDS and the disabled in the field of affordable housing.

I met all those objectives and I wish to continue to my service.

One of my specific objectives as the Mobilehome Resident Representative would be to aid in the maintenance of a collegial environment on the Commission especially with my colleague who represents the Park Owners. In the next few years we will be making recommendations on highly emotional issues. As Chair, and as a Commissioner, I have served as a bridge during many contentious discussions. I am respected across the board and this standing will help facilitate a healthy and respectful environment. We can disagree without being disagreeable.

## Please state any other information which you feel would be useful in reviewing your application:

As an HCDC Commissioner, I have never missed, or been late, for a meeting. I had the same record on the Senior Commission and the Human Rights Commission. I have always taken on leadership positions in those entities and given 200% to whatever job I was assigned.

In 1994, I was told that I could not mobilize enough financial and logistical support as a Human Rights Commissioner to bring the AIDS Memorial Quilt to San Jose. Putting together a coalition of University, City, business and civic groups, I did it. I do not accept that something worth doing is impossible until I have done all I can to try to make it happen. The appreciation book signed by all those with whom I worked for a year to make the Quilt Display possible is one of my proudest possessions.

### Please describe your experience on serving on a Board or Commission:

I was appointed to the HCDC effective 4-29-14 as the D1 representative. I served two terms as the Chair. My nomination for Chair was supported by both the Park owner representative, Commissioner Mike Graves, and the Park resident representative, Davlyn Jones. My reputation for fairness and effectiveness is evident by that dual support and was thereafter recognized on the last day of my second term as Chair when Commissioner Michael Fitzgerald recommended that the City present me with an award. Numerous Commissioners joined with him in that recommendation. My deep as well as broad knowledge of housing issues has been demonstrated by letters and reports I have written to Council as well as public testimony. I have been one of the most active, articulate and informed members of the HCDC during my tenure.

In December 2017, due to the resignation of the Mobilehome Resident Representative, I resigned my D1 seat and was appointed to fill the remaining one year term. I am now applying for the four year full term as the Mobilehome Resident Representative.

I was appointed to the Senior Commission in 2008. At my request I was placed on the Housing and Human Services Subcommittee (HHS), one of the two standing subcommittees of the Senior Commission.

2008 - 2009 - Secretary for the HHS

2008 – 2013. Liaison from the Senior Commission to the MAC – Mobilehome Advisory Commission. Perfect attendance. Never missed a MAC meeting. It is critical to note that the Senior Commission had had no liaison to the MAC for years. It was my idea to reactivate this liaison appointment since Mobilehomes represent one of the most affordable housing options in San Jose for Seniors.

2008 – 2013. One of three liaisons from the Senior Commission to the old HCDC Commission.

2013-14. One of three liaisons from the Senior Commission to the new HCDC Commission.

2008 – 2013. Frequent attendee at the ACR, Advisory Commission on Rents.

2010-2011 - Vice Chair of the Senior Commission

I was appointed in December 2016 as the Zone A-1 Associate Manager for the Golden State Manufactured and Mobile Home Owners League (GSMOL). In December 2017 I was promoted to Region Manager. GSMOL is the largest state organization representing mobilehome residents. I serve as a resource person for folks in the counties of Santa Clara, Alameda, San Mateo, Contra

Costa, and San Francisco. I am active with GSMOL's state lobbyist in the area of new legislation. I participate in continuing training sessions on housing issues.

On June 30, 2018 I hosted a Regional Mobilehome Owners Conference in San Jose. Residents from 31 different Parks and 13 Cities attended this all day Conference. I attach the program brochure.

In May 2017 I was awarded a "Mobilehome Residency Law Master Certificate" after weeks of training and passage of an exam. The Mobilehome Residency Law is "the Bible" of mobilehome law – a state law.

In 2005, I founded HOME, Homeowners Organized to Maintain Equity, an advocacy group for residents of mobilehome Parks. From 2005, I have immersed myself in Mobilehome issues, publishing a monthly newsletter, sponsoring information meetings with the City of San Jose's Housing Department, and interacting with Project Sentinel, the Asian Law Alliance and the Mental Health Advocacy Project to address issues in mobilehome Parks.

I did not miss a single meeting of the MAC during the time it was a standalone Commission from 2005 to its consolidation with the old HCDC. My knowledge of the mobilehome Ordinances, as well as on point case law, is extensive. My computer room is a veritable library of laws, codes, and case law on housing issues. In September 2008, I authored a report on mobilehomes and the San Jose mobilehome ordinance for the Senior Commission to use as a resource guide.

In the 2013 City of San Jose rent increase petition administrative hearing before Judge Michael Lowy, I held 89 proxies, representing over 100 folks in a proceeding held pursuant to the City's Mobilehome Rent Control Ordinance. The previous year, I was my Park's liaison to the attorney who was then our representative. As a member of the HHS subcommittee, I have immersed myself in housing issues since 2008. I have written countless letters to the Council on housing in my position as Chair of the HCDC and Senior Commissions and testified at Rules and City Council on equally countless occasions.

As an attendee at the Advisory Commission on Rents (ACR), I was jokingly referred to by a representative for the Landlords as "the public" since so few citizens attend those meetings. She then presented me with a copy of "The California Fair Housing Encyclopedia" at an ACR meeting as an acknowledgment of my commitment to the ACR meetings.

As a years old attendee of the HCDC before my appointment, I was far from passive. My concerns and insights have been recognized in the HCDC minutes for years.

Prompted by a story in the Mercury News about an unidentified Senior who died in a homeless shelter, I facilitated four presentations to the Senior Commission or the HHS on the issue of

homelessness from both City staff and Lifebuilders. I made a site visit to the Little Orchard Shelter and advocated for the position of Case Manager. I am a member of the Affordable Housing Network and have worked with CHAM (Community Homeless Alliance Ministry) and HOMELESS.

### What is your understanding of the purpose of the Commission?

The Housing and Community Development Commission (HCDC) consists of 13 members who advise the Director of Housing, the Mayor, and the City Council on housing and community development matters, including the Community Development Block Grant (CDBG) program.

It is also one of the organs that serves as the site for mandated, official public hearings for various housing and community development issues.

### Please list three issues facing the City that you feel the Commission should address:

1. In the last four years on the HCDC, I have learned a very important lesson: the City needs to do better outreach to the Community when it comes to housing issues. Whether it be the housing for the homeless projects at Senter Road and Evans Lane, the creation of a new mobilehome closure ordinance, or the changes to the apartment rent stabilization ordinance, we have heard over and over from the stakeholders that they need more meetings, more information and clearer information. This was addressed by Councilperson Tam Nguyen in a letter to the Rules Committee, agenda packet for 2-15-17 Rules meeting.

I have advocated during my entire HCDC tenure that the public meetings must not only be at night but during the day as well. Many Seniors do not drive at night. Additionally I witnessed numerous folks from Evans Lane and other neighborhoods tell the Council that they depend on public transportation and getting off at, for example, the Curtner light rail station at night is unsafe. I have also consistently advocated that the distribution of meetings notices be in multiple languages and that translators be at all meetings. If we want public buy in, we need to do better. If we want to be a representational government, we need to do better. I have also advocated for standalone Council meetings when we know that hundreds and hundreds of folks will be coming to testify.

2. Local housing issues are tied to state issues. A minority of apartments are covered under rent control. If passed by the voters in November 2018, Prop 10, the repeal of the Costa Hawkins Act, will have a tremendous impact on solving the affordable housing crisis. In 2017, I wrote "We need to work with other cities and counties for a repeal of Costa Hawkins."

3. Aging Infrastructure in mobilehome Parks. Mobilehomes are one of the last bastions of affordable housing, especially for Seniors. The failure of many of the park owners to set aside monies to pay for infrastructure repair should not be used to justify a run around rent control.

### What experience do you have with affordable housing issues?

From 2005 to date advocating through HOME.

From 2008 – 2014 with the Housing and Human Services subcommittee of the Senior Commission.

From 2008 – 2014 with the Senior Citizens Commission.

From 2004 and continuing Representation of numerous Senior and disabled folks with their housing problems - interfacing with Asian Law Alliance, Project Sentinel, the Law Foundation, and the Mental Health Advocacy Project.

As Chair of the SJSU HIV/AIDS Committee, I initiated a person from the homeless community to be a participant in our annual "World AIDS Day" series of events. The issue of the incredible challenges for a person living with HIV/AIDS while a member of the homeless community was a new consideration for the SJSU Committee until I brought it to the fore. I worked with CHAM (Community Homeless Alliance Ministry) to secure a speaker and maintain one annually.

Have attended informational meetings held by CHAM (Community Homeless Alliance Ministry), marched in demonstrations for affordable housing, served food to the homeless during holiday outreaches, and collected blankets, clothing and food for the folks.

### Please explain your familiarity with the Community Development Block Grant Program.

The Community Development Block Grant Program is a federal program that awards the City money to help low and moderate income folks, address an urgent community need, and prevent or eliminate slums or blight, such as homeless encampments. The City awards money on a competitive basis to NGOs.

As an incumbent HCDC Commissioner, I have made recommendations to the Housing Department on the awarding of such funds. In 2012, I served on a San Jose City grant panel to make recommendations for the awarding of CDBG money to such programs as the Housing Trust Fund, SALA, Meals on Wheels, Catholic Social Services, and the Billy De Frank Center. I have attended numerous stakeholder meetings since 2008 held by the City to obtain input on prioritizing the expenditures of HUD monies and CDBGs. Attended all the 2010-2011 meetings of the joint County/City Senior Nutrition Program Task Force which developed a strategy to save

the Senior Nutrition Program which had been slated for total elimination. Prior to joining the HCDC, I was frequently one of the limited number of members of the public to attend the **mandated hearings** held by HCDC on the recommendations for the awarding of the CDBG grants. I have personally facilitated contact by mobilehome park residents with the Housing Department to apply for grants funded by CDBG money for rehabilitation to make their homes decent, safe, warm, and sanitary. I have hosted informational meetings with Rebuilding Together, one of the recipients of CDBG funds. Served on the PRNS Ad Hoc Committee to help come up with the scope of the RFP for the ongoing selection process for the nutrition vendor (2013). In late 2013 I was then selected to move onto the seven person panel to interview and rate the candidates for the final award of the RFP.

I was in attendance on September 12, 2013 when Housing staff made a formal presentation to the HCDC, "Overview of Federal Funding" that included CDBG.

### I would like to say

I have striven to be a fair and informed HCDC Commissioner since my initial appointment. I have the respect of my fellow Commissioners across the board, regardless of whether or not we agree on specific issues. I am passionate about housing issues and want to serve a full term as the Mobilehome Resident Representative to continue to contribute to the City of San Jose. My letters of recommendation have two important themes: I am extremely knowledgeable and I am fair.
