# SUBJECT: TRANSFER COUNCIL DISTRICT FUNDS FOR INCOMING COUNCILMEMBERS DURING "TRANSITION YEARS" AND ADOPTION OF APPROPRIATION ORDINANCE AMENDMENTS IN THE GENERAL FUND

#### **<u>RECOMMENDATION</u>**

(a) Adopt the following 2018-2019 Appropriation Ordinance amendments in the General Fund:

- (1) Increase Council District #07 appropriation by \$421,550;
- (2) Decrease Council District #07 (January June) appropriation by \$421,550;
- (3) Increase Council District #09 appropriation by \$448,055; and
- (4) Decrease Council District #09 (January June) appropriation by \$448,055.

#### **OUTCOME**

The recommended actions will transfer the appropriations set aside for the incoming Councilmembers' use to the main operating appropriation for each Council District.

#### **BACKGROUND**

Operating Budget Section 20, Office of the Mayor and City Council District Office Budgets in Transition Years, of Council Policy 1-18, Operating Budget and Capital Improvement Program Policy, provides that for fiscal years in which the term of office of the Mayor or Councilmember(s) will expire (a "Transition Year"), two separate appropriations to maintain separate budget allocations for the outgoing and incoming elected officials shall be established. The total budget allocation will include: (a) office general budget; (b) constituent outreach budget; and (c) any carryover available from the prior fiscal year, from both office general and constituent outreach budgets. The first appropriation shall be for the July through December period for the Councilmember(s) whose terms expire in December of that year, representing 50% of the total allocation. The second appropriation shall be for the January through June period for the newly elected Councilmember(s), representing the remaining 50% of the total allocation.

### ANALYSIS

Per Council Policy 1-18, Operating Budget and Capital Improvement Program Policy, two separate appropriations were established in 2018-2019 for Council Districts 7 and 9 which were in a transition year with an outgoing and an incoming Councilmember. With the incoming Council members starting their terms in January, the appropriations holding the funds for the second half of the fiscal year need to be re-appropriated to the main operating appropriation for each Council District for use by the new Councilmember for the continued operations of the office.

No additional follow up action is necessary.

There is no net fiscal impact to the General Fund associated with the recommended actions. The adjustments requested will re-appropriate the funding for the second half of 2018-2019 to the main operating appropriation for Council Districts 7 and 9, resulting in a net zero transaction.
