RECOMMENDATION

1. Retroactively approve the Beautility Art Celebration even scheduled Saturday, December 8, 2018, as a City Council sponsored Special Event and approve the expenditure of funds.

2. Approve and accept donations from various individuals, businesses, or community groups to support the event.

3. Place the item on the December 18, 2018 Council Agenda for action.

BACKGROUND

The District 10 Council Office has worked with the Public Art Department of the Office of Cultural Affairs to beautify concrete utility enclosures in TJ Martin and Jeffrey Fontana Parks. Funds for this project came from the District 10 Park Art budget; the project was managed by the Public Art department and approved by the Public Art Committee. The community was involved throughout the project and has provided much positive feedback. The project was very successful, despite various challenges and delays.

The project was initially scheduled to be completed by late spring, concluding with a celebration event with the community. However, there were several delays, most recently the smoke from the Paradise Fire. It was unclear when a celebration event would be able to be scheduled. As we are heading into the rainy season it was quickly decided to host the event on Saturday, December 8th. The Council office purchased refreshments and balloons for the event.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. Approval of this memorandum will enable Council District 10, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
