RECOMMENDATION

1. Retroactively approve the East Hills Neighborhood Association Community Gathering scheduled on December 15th as a City Council sponsored Special Event and approve the expenditure of funds.
2. Approve and accept donations from various individuals, businesses or community groups to support the event.
3. Place the item on the January 8, 2019 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The East Hills Neighborhood Association Community Gathering will be held on December 15, 2018 at Valle Vista Elementary School and sponsored by Councilmember Sylvia Arenas. This special event is meant to encourage neighborhood camaraderie through activities for families and share City information and resources. The event is free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Sylvia Arenas will report any cash or in-kind donations received
