SUBJECT: RETROACTIVE APPROVAL OF SMALL BUSINESS ADVOCACY TASK FORCE (SBATF) MEMBERSHIP RECOGNITION EVENT SPONSORED BY COUNCIL DISTRICT 1 AS A CITY COUNCIL SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE EVENT

RECOMMENDATION

- 1. Approve the SBATF Membership Recognition Event scheduled on December 17, 2018 as a City Council sponsored Special Event and approve the expenditure of funds.
- 2. Approve and accept donations from various individuals, businesses, or community groups to support the event.
- 3. Place the item on the January 29, 2019 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

SBATF Membership Recognition Event was held on December 17, 2018 at Olla Cocina and sponsored by Councilmember Chappie Jones. This special event recognized members of the SBATF for their hard work and dedication for attending meetings and advising Councilmember Jones on public policy issues relevant to small business issues. The event is free and open to the public.

ANALYSIS

Retroactive approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Chappie Jones will report any cash or in-kind
