## RECOMMENDATION

Accept this staff report which describes the outreach and engagement action plan performed by Public Works on Citywide Public Works Contracting Program to implement the City of San Jose Department of Public Works strategy of "Building our City together with our Community".

# **BACKGROUND**

At the June 23, 2015, City Council Priority Setting Session, staff was directed to return to the Community and Economic Development Committee (CED) with a strategy to implement a Disadvantaged Business Enterprise (DBE) Program. Engagement Action plan, and recommendations for any disadvantaged business enterprise preferences for public works procurement.

## **ANALYSIS**

The traditional focus for procurement of contractors for public works projects has been more of a market driven focus where the City would post a project for bidding and rely on the market to supply the best contractors. Of course there are many examples where staff have been more proactive, but, as a general rule, the City has not been proactive in developing the market.

In today's competitive construction environment, it is not sustainable to simply "post and pray" and hope that we obtain the best quality contractors. Additionally, it is also important that we not only obtain the best "final products" on our construction projects, but we also allow our community to participate in the construction of the projects. By doing so, we will create more opportunities for our local residents to succeed in life and we will strengthen our local workforce and economy. This philosophy has led to a new strategy within our Public Works Department called "Building our City together with our Community". This strategy consists of the following three areas which are described in more detail in the following sections:

- 1) **Public Works Academy** to connect, educate and inform our local contracting community;
- 2) **Procurement Policy Changes** to provide greater opportunities for our local, local small and disadvantaged businesses and workers to participate in San Jose construction projects;
- 3) **Internal Staff Training** to ensure our project managers are designing projects that facilitate local, small and disadvantage business participation.

#### Public Works Academy

City staff have worked with the Silvy Group to create the San Jose Public Works Academy. Bob Silvas, owner of the Silvy Group, retired with close to 25 years of service from the San Diego International Airport as the Director of Small Business, a position he held since 2003. Mr. Silvas emphasizes building capacity and maximizing participation through collaboration. By expanding partnerships with local agencies, trade associations, chambers of commerce and special interest groups, he creates the opportunity to build bridges and for stakeholders to become part of the solution. Silvy Group is focusing on discovering and addressing common challenges and barriers all small businesses face when working with public agencies to ensure that the pool of qualified vendors begins to reflect the local business demographics.

The approach developed by the City and Silvy Group is a multi-faceted effort that consists of the following:

• Public Works Academy Opportunity Awareness Events: Opportunity Awareness Events are in-person workshops designed for face-to-face contact between Public Works staff and the contracting community. The workshops will focus on contractor networking, upcoming opportunities, registration for the vendor management system (Bidsync), minimum requirements for contracting with the City, and information for online tutorials, future educational programs, and the Public Works Academy of Construction Management. Public Works mailed notification cards to 2300+ construction businesses found in the San Jose Business License Tax database and communicated the dates to all of the council offices. The first event was held on January 15<sup>th</sup> at Bascom Community Center and was attended by 11 representatives from the contracting community. The remaining dates are:

- o January 17 9-11am at the Vietnamese American Community Center
- o January 29 9-11am at Southside Community Center
- o February 4 1:30-3:30pm at Berryessa Community Center
- o February 5 5:30-7:30pm at Evergreen Community Center

In addition, to the increased awareness and opportunities to participate on San Jose projects, the City entered into grant agreements with the Hispanic Chamber of Commerce Silicon Valley and the Silicon Valley Black Chamber of Commerce in the amount of \$25,000 each in an effort to increase awareness and expand communication with underrepresented businesses. The Online tutorials, Opportunity Awareness Events, and Public Works Academy of Construction Management will continue to be marketed at these events.

• <u>Public Works Academy Seminars</u>: Seminars have been developed that will cover indepth training for contractors and vendors on public works construction projects. In addition to being valuable learning tools, these seminars will allow contractors to check the "experience box" on certain city public works procurement processes allowing them to bid on certain projects even if they haven't worked on a public works project in the past. The free seminars are currently scheduled to occur:

- <u>Social Media:</u> The Silvy Group has developed, in coordination with Public Works staff, ten (10) YouTube videos examining and explaining the requirements and process for entering into a construction contract with the City. This includes but is not limited to: (1)

Prevailing Wage, (2) Bonding, and (3) Insurance. Contractors are able to view the videos multiple times and at their own convenience.

# **Procurement Policy Changes**

Public Works is in the process of making numerous procurement policy changes (Appendix A) that have a direct benefit to the local, small, and disadvantage businesses. They include:

- Minor Public Works Projects Threshold— As approved by Measure S in November 2018, increase the threshold for minor public works projects from \$100K to \$600K, making a wider portfolio of projects available for a more simple bidding process, therefore increasing the ability for small and local small business participation.
- Minor Public Works Prequalification Process— A process to "pre-approve" contractors to work on minor public works projects. This will dramatically reduce the time and effort required for city project managers to engage minor contractor in work opportunities.
- Additional SBE, MBE, DBE contract goals and programs— Potential creation of additional programs such as (1) Small business enterprise contract participation goals (2) implementation of an economically disadvantaged business program (3) goals/good faith disadvantaged business program (4) goals/good faith efforts for minority and/or women based business enterprises; (5) sheltered programs for small business enterprises; (6) working capital program to assist contractors to meet bonding requirements.

Each policy change requires information to be disseminated and procedures to be explained. To address all the upcoming policy changes Public Works intends to continue the Public Works Academy with Opportunity Awareness Events performed quarterly and Public Works Seminars bi-annually. The Master Consultant agreement with Silvy Group will end in August 2019. Funding sources for on-going work are being examined to ensure sustainability of the program.

Moving forward, staff will continue to monitor, analyze and report to the Mayor and City Council on the above policy changes and practices to ensure that the Public Works policy of "Building our City together with our Community" is resulting simultaneously in great final projects as well as opportunities for our local businesses and workforce.

# Internal Staff Training

While it is important to create policies and tools which enhance the opportunities for local, local/small and DBE businesses to participate in City Public Works projects, these policies will not be useful unless they are fully embraced by the City workforce. Additionally, the City's project managers must also design our projects to align with these new policies. As we continue to move forward, project managers in Public Works are being trained on these policy changes

and are being encouraged to design their projects to encourage more small subcontracting opportunities which, in turn, will provide more opportunities for local and local/small business participation.

Staff and the consultants will return to CED Committee in June with additional findings, data on the effectiveness of Outreach and Engagement Action plan, and a discussion on the next phase of development of polices to encourage local, local/small, DBE and local workforce participation in the delivery of San Jose's Capital Improvement Program.
