SUBJECT: APPROVAL OF THE PROJECT HOPE LITTER PICK-UP AND DUMPSTER DAY AT ROUNDTABLE DRIVE AND WELCH PARK CO-SPONSORED BY THE MAYOR'S OFFICE AND THE PARKS, RECREATION, AND NEIGHBORHOOD SERVICE'S PROJECT HOPE AS A CITY COUNCIL SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE EVENT

RECOMMENDATION

1. Approve the Project Hope Litter Pick-up and Dumpster Day at Roundtable Drive (D2) and Welch Park (D8) scheduled on Saturday, February 23, 2019 as a City Council sponsored Special Event and approve the expenditure of funds.
2. Approve and accept donations from various individuals, businesses or community groups to support the event.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Project Hope Litter Pick-up and Dumpster Day at Roundtable Drive and Welch Park will take place in the Roundtable Drive and Welch Park neighborhoods and is co-sponsored by Mayor Liccardo and the Parks, Recreation, and Neighborhood Service's Project Hope. The event is free and open to the public.
