#### RECOMMENDATION

#### **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The purchase of event supplies and food on the February 6th at Toyon Elementary School sponsored by Councilmember Magdalena Carrasco. This special event is for our District 5 residents and leaders to recognize their contributions to District 5. The event is free and open to the public.

### <u>ANALYSIS</u>

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Magdalena Carrasco will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1).
