A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE AUTHORIZING “FREE USE” FOR EVENTS AND ACTIVITIES HELD AT CITY HALL FOR THE 2019 SOUTH BAY TRANS DAY OF VISIBILITY ON SATURDAY, MARCH 30, 2019 CO-HOSTED BY THE COUNCIL DISTRICT 6 OFFICE AND BILLY DEFRANK LGBTQ COMMUNITY CENTER

WHEREAS, in June 2016, the Council of the City of San José (“City”) adopted Schedule of Fees Resolution No. 77829 for the fees and charges for City Hall Facility Use; and

WHEREAS, Resolution No. 77829 authorizes the City Council, Redevelopment Agency Board, and City departments to have “Free Use” of the facilities for those events that 1) qualify as official City business; 2) are free and open to the public; 3) occur on a Sunday through Friday; and 4) are booked 30 days in advance; and

WHEREAS, Resolution No. 77829 does not apply to free use requests for Saturday events, and as such City Council approval is required; and

WHEREAS, the Council District 6 Office has requested that “Free Use” be authorized for events and activities for the 2019 South Bay Trans Day of Visibility, which is expected to significantly benefit the City if scheduled on a Saturday as it would accommodate the schedules of community members who work full-time jobs during the week and increase the number of participants; and

WHEREAS, the 2019 South Bay Trans Day of Visibility is co-hosted by the Council District 6 Office and the Billy DeFrank LGBTQ Community Center and directly aligns with top City priorities and policies by providing access to information for a diverse population that includes transgender/nonbinary/intersex people; and

WHEREAS, the City finds that the 2019 South Bay Trans Day of Visibility supports the City's mission to provide quality public services, facilities and opportunities that create, sustain, and enhance a safe, livable, and vibrant community for its diverse residents, businesses, and visitors; and

WHEREAS, the City desires to allow for the free use of the City Hall Rotunda, Wing Committee rooms, and parking in the City Hall Garage and 4th Street Garage for the 2019 South Bay Trans Day of Visibility on Saturday, March 30, 2019;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT:

The City Council hereby authorizes "Free Use" of the City Hall Rotunda, Wing Committee rooms, and parking in the City Hall Garage and 4th Street Garage for events and activities for the 2019 South Bay Trans Day of Visibility on Saturday, March 30, 2019 co-hosted by the City of San José Council District 6 Office and the Billy DeFrank LGBTQ Community Center.
