Re: March 12 Agenda Item 5.2: Please do not give Arena Green away

Honorable Mayor Liccardo and San Jose City Council members,

The Sierra Club Loma Prieta Chapter, the Santa Clara Valley Audubon Society, the California Native Plant Society Santa Clara Valley Chapter, the Committee for Green Foothills and Keep Coyote Creek Beautiful are local organizations that protect and promote open space, parks, riparian corridors and the species that live in these important landscapes. Together, we have engaged in support of good planning in the City of San Jose (Measures C, T) and in opposition of bad planning (Measure B). We now write to ask council to reject the development of a monumental structure in Arena Green, and to ask the Light Tower Corporation (LTC) to look for an alternative location for their project.

Arena Green is an extremely sensitive habitat at the confluence of two major riparian waterways, the Guadalupe River and the Los Gatos Creek. The two streams provide habitat and critical riparian corridors for endangered steelhead anadromous fish and other wildlife negotiating through an urban center. The rivers also create a migratory birds flyway. **Arena Green is the biological gateway to the Guadalupe and Los Gatos watersheds** - It provides birds, fish and other animals the means for dispersal on the valley floor, and into the foothills and the Santa Cruz mountains.

In a site as important as this, space around the creek is the most critical element. Without a significant buffer between human activities and the creek, the corridor will cease to function as a pathway for animal movement and migratory birds, and will become a hazard instead.

San Jose is already lacking sufficient park space for its residents. With projected increases in our population, committing park space for a structure of unknown size doesn't make sense. Building on Arena Green decreases the availability of public open space. A different site should be selected.

We are troubled that the site selection study conducted by Steinberg Hart on behalf of LTC concluded that there would be no un-mitigable impacts to the environment at this site. Given that there was no analysis of the harm the proposed development could impose to Arena Green, such a conclusion is baseless. It seems that this study focused on the potential impacts that the environment could have on the development of the project—the exact opposite of what environmental analysis should be. This is critical flaw in the initial site selection study. The San Jose Parks and Recreation Commission also found the site selection study to be flawed, and declined to recommend Arena Green.

The selection of Arena Green exacerbates the complications of the LTC development proposal. The structure's form is to be determined by a design competition—one where the winning project is not selected by the public but instead by jurors selected by LTC. The name "Light Tower Corporation" and the light-themed branding of their website will surely invite night-lighted structures. In both public and private meetings, LTC has not backed off of the possibility that this structure will be illuminated at night. Artificial light at night has been scientifically proven to be extremely harmful when placed in riparian habitats. It can also affect the movement of the salmon that travel through the waterways of Arena Green. These impacts will only further complicate the political and design process of the proposed development. It is in the interest of both LTC and the citizens of San Jose that this development be constructed in an area where it does not pose such a serious risk of causing ecological damage and conflicts.

Public art is often fraught with controversy, and a development as complicated as this must start off on a solid foundation. The selection of Arena Green puts this project on very shaky grounds. The trajectory is a situation where conflicts cloud the possibility of a successful iconic project for San Jose. We ask you to direct LTC to consider an alternative location, a location that garners the support of the entire community.

Dear City of San Jose Council Members:

California Trout is writing to support the adoption of Guadalupe River Park at Arena Green as the preferred site for an iconic monument for the City of San Jose.

California Trout is statewide conservation organization that has been headquartered in the Bay Area since its founding in 1971. We solve complex resource issues by balancing the needs of wild fish and people. As California Trout's Bay Area Program Manager, I am tasked with carrying out recovery actions to de-list threatened Central California Coast steelhead (*Oncorhynchus mykiss irideus*) from the Endangered Species List here in the Bay Area. Steelhead once inhabited Guadalupe River watershed in significant numbers

prior to the construction of dams, levees, canals, and other development in the watershed, and the Guadalupe was identified as an anchor watershed necessary for their recovery by the Center for Ecological Restoration and Management in 2007: http://www.cemar.org/SFEWE/Full%20report.pdf.

Despite significant urbanization and development and downward statewide trends (www.caltrout.org/sos/), some steelhead still call the Guadalupe River home and make their way through the Arena Green Reach every year. Due to its size and relatively intact spawning tributaries, resource agencies have identified the Guadalupe River watershed a high priority for steelhead restoration. As such, we are interested in seeing it managed in a way that allows recovery of this iconic species that is an indicator of watershed health upon which we all depend.

We see this project as an opportunity to generate significant public interest, education, and restoration of a site that is important to native fishes that is contingent upon it being sited at Arena Green. The existing design and land-use of the Arena Green site offers very little suitable habitat for native fishes and it is in desperate need of improvement. The Arena Green reach lies at the confluence of Los Gatos Creek and the mainstem Guadalupe River, a strategic site which is a known spawning area and staging area for migrating fish moving upstream. We believe the site could be meaningfully improved with site designs that incorporate larger riparian habitat buffers, large woody debris cover, and impervious surfaces, as well as viewing areas for the fish as an important public awareness and education component of the project.

I have personally met with members of the San Jose Light Tower Corporation and am confident in the group's integrity and commitment to an inclusive process to ensure their project does not negatively impact fish or wildlife. I look forward to turning an existing eyesore of homeless camps and extremely poor fish habitat currently at the site into a project that could improve the local environment for fish, wildlife, and people.

We respectfully request your approval of the Arena Green site for the proposed landmark project. Please don't hesitate to contact me if you need any additional information.

Dear Honorable Mayor Liccardo and Honored Members of City Council,

On behalf of the Shasta / Hanchett Park Neighborhood Association, I would like to thank you for the opportunity to comment on the proposed Light Tower Monument site.

The Shasta / Hanchett Park Neighborhood Association represents 4,500 households in neighborhoods immediately West of Diridon Station, an area of the City that is severely underserved in parks. As additional residents move into the area, the residents-to-parks ratio will continue to worsen. Sadly, this widening disconnect is not unique to our neighborhood parks, and it has been exacerbated by previous Council policies, including, but not limited to, the inclusion of school lands in parkland calculations.

We are therefore concerned by the proposed use of the Arena Green for the San Jose Light Tower Monument. The taking of existing parklands for such a project at this time seems short-sighted, while also ignoring multiple concerns and inconsistencies in the selection process. The City is in the midst of negotiations for a once-in-ageneration comprehensive mixed-use development barely a block away, which would benefit from an iconic structure such as the proposed Light Tower. Any project of this scale must be considered carefully; moving forward with the Arena Green site because it is ready and waiting, instead of incorporating such a structure into a project that, by its very nature, is destined to be an iconic destination for San Jose, Northern California, and much of the Western United States, is ill-advised.

At yesterday's Station Area Advisory Group (SAAG) meeting, the intricate process of the Diridon Integrated Station Concept (DISC) was discussed at length. Multiple members of the Group emphasized that expedience on the part of a single transit entity cannot be allowed to compromise the overall station concept. Moving forward with the Light Tower in its current proposed location is similarly penny wise and pound foolish, putting project schedule above coherent, thoughtful design. The SAAG has been tasked with publicly discussing the Community Benefits of any development proposal Google puts forward. As the Neighborhood Association's representative on the SAAG, a member of the SAAG Land Use and Urban Design Solution Group, and a member of the SAAG Parks, Public Spaces, Neighborhood Quality of Life, and Sustainability Solution Group, I can attest to the fact that quality of life through coherent open public spaces was emphasized throughout the SAAG process. The Light Tower proposal could be an integral part of this process; instead, what you have before you is a proposal that, in many ways, is in direct contradiction to the findings and stated goals of the SAAG. To call this a missed opportunity would be an understatement of generational proportions.

We therefore ask that the Council reject the site analysis. The City would be better served by asking the project proponents to work with Google as part of the proposed Diridon Station Area development. Google is endeavoring to be a strong, dynamic partner with the City. What better way to emphasize the placemaking of Google's development, and Diridon Station as the envisioned "Grand Central Station of the West", than to have an iconic structure be part of the public open space one sees upon arriving at Diridon Station? Placing it at the Arena Green, in proximity to the riparian corridor, would seem to marginalize the siting, while potentially harming the existing parklands, for the sake of expedience. Given the likely construction staging for BART Phase II and other pending projects, a Light Tower project completed on the Arena Green would be completed just in time to be surrounded by construction impacts. Why not take the time to incorporate the Tower into San Jose's single largest redevelopment project, by making it a signature element of the Diridon Station revival?

We take pride in our neighborhood; S/HPNA Board members and volunteers have been diligent advocates and volunteers in our parks for many years and will continue to do so. Therefore, we ask you to match this dedication. Our community can only benefit from your support today. We look forward to being a part of the process to address quality urban planning, public safety, and truly livable amenities for our diverse community.



Dear Mayor Liccardo and San José Councilmembers,

We on the San José Parks and Recreation Commission were asked in December to "Accept the status report of the San Jose Light Tower Corporation (SJLTC) regarding the Site Selection Study results and the concept of an International Ideas Competition." The study recommended selecting Arena Green as the site for the gift of an "iconic structure". At the Commission meeting, I made the motion that passed to decline approving the recommendation and instead to defer the selection of the site to you on the City Council, and to ask that you first clarify various issues, address some concerns, and establish the necessary design constraints. The recent SJLTC public outreach meeting addressed some of these issues, but many remain. I am writing this letter, as an individual, to give some background for my motion.

As I told the chair of the San Jose Light Tower Corp., Steve Borkenhagen, I agree that San Jose lacks an iconic image for itself -- even the San José Parks Dept. used the 280/87 freeway interchange for the cover photo for its 2000 "GreenPrint". I appreciate SJLTC's generous offer to donate to San José an art structure that could become an iconic image for the city. However, I was concerned by details of the site-selection trade matrix, and I couldn't approve giving "a blank canvas" (to "not constrain the creative spirit") for a project that lacked adequate design guidelines, constraints, specifications, and review processes. And, as a life-long advocate for creeks and trails and parks and the environment, I feel a special sense of protectiveness for the Los Gatos Creek and Guadalupe River at Confluence Point in Arena Green. Also, I feel an icon is something that is chosen by the public, not given by a donor.

What makes an icon? Not every big city has an icon, and not every city icon is big. Seattle has the Space Needle, Paris has the Eiffel Tower — and, before that, San José had The Light Tower, a scale-model of which now resides in our History Park. (San José was also famous for the waters of Alum Rock, the first park in California: maybe we could have a fountain?) An icon does not have to be merely some ornamental structure: it can be something useful, like San Francisco's Golden Gate Bridge or Sydney Australia's famous Opera House. It doesn't need to be large: Chicago is famous for its silvery "Bean", and Copenhagen Denmark's "Little Mermaid" statue is barely life-sized. It doesn't even have to be a structure: San Antonio Texas is rightfully famous for its "River Walk". And it doesn't have to be downtown: think of LA's famous Hollywood sign. Representatives of the San Jose Light Tower Corporation said that they want to hold an international design competition for any and all ideas for an icon, but when the sponsor has "Light Tower" in the name, one is likely to get a Light Tower as the submitted design.

The Parks & Rec Commission was asked to approve the selection of Arena Green as the site for this gift. The site selection was based on a weighted scoring of selection criteria. There were no constraints on the amount of land to be given over to this icon: is it the small footprint of a Mermaid-sized statue, or is it the entire footprint of the park? The briefing document showed an all-encompassing envelope covering 240,000 sq.ft: would the public lose their free access to much or all of the park? What about the trail connections? Also, Arena Green is in the airport's flight-path: an icon there could only be the size of a typical transmission tower and just half the height of the original tower, and it wouldn't even be seen by airline passengers. I also expressed a number of concerns about the site selection process itself:

• The trade was from a quite limited selection of sites: mainly a few of the downtown city parks. Coyote Meadows (with the landfill just across I-280 from downtown) was not considered, nor City Hall Plaza, nor any private land. I feel that if this is going to be a "gift" to the City, it could include a gift of the land as well, rather than costing the public its access to one of our parks.

- The scoring seemed capricious. For example, Discovery Meadows was given a low score in part due to "poor public transit", even though there's both a light-rail station and a major bus stop right there on the site's perimeter.
- The scoring was skewed: "environmental influences" were interpreted to mean impacts <u>to</u> the gift rather than impacts <u>by</u> the gift. The report recommended Arena Green in part because of the "little environmental influences thanks to the flood control systems" and that the area is "free of heritage trees and historical influences" there was no consideration given to the impact of noise and light <u>on</u> the sensitive riparian (creekside) habitat or the bird flyways. Arena Green is one of the most environmentally sensitive parks evaluated, and the presented plan even disrespected San José's Riparian Setbacks with an envelope that encroached on the Los Gatos Creek. (The charts presented at the public outreach meeting did show a larger setback.)

The donors plan an international competition, with the design selected by a jury of international judges. I'm sure they all will have the best of intentions, but I have seen past committees elsewhere approve statues of Confederate generals in the American South, statues of Lenin for Eastern Europe, or even gilded statues of the donors. And we need to avoid accepting the classic "White Elephant" – a "prestigious" gift that can't be used and that is expensive to maintain. The City needs to maintain control over the final approval process, and to involve the public in the design specification and selection process.

My requests of you on the City Council:

- Discuss what San José wants in the way of an "icon". Ask the public: should it be some squat Light Tower or other ornamental structure or object, or could it be something more "useful"? Could the donors combine resources with others, perhaps, for example, contributing towards making a more magnificent and iconic station for the trains, BART, and High Speed Rail; or helping to build a truly iconic HSR bridge/entranceway into San José; or maybe restoring a natural habitat and creating a "San José-style" River Walk along the Los Gatos Creek.
- Consider alternative sites: Discovery Meadows, Coyote Meadows, City Hall Plaza, non-down-town sites, even non-city-parklands. If it is to be at a city park, put an upper limit on the amount of public land to be given over to the icon, and assure that the trail network is not degraded.
- Respect the riparian habitat: no incompatible development anywhere near the 100-foot setback zone; no light directed into the habitat; control of contaminants, runoff, public impacts, noise, soil compaction, etc.
- Respect the birds: the creeks are natural flyways, and whatever project is selected should be
 designed to avoid distracting or imperiling the birds: no lights directed into the bird flyways, no
 windows or glass panes, and no wire meshes or other hazards.
- Avoid negative impacts to the city: no lights flashing at the aircraft taking off from San José International, or shining into the windows of downtown high-rises.
- Require City oversight: an International Selection Committee can assist with the design competition, but the Parks & Rec. Commission, Arts Commission, and Historic Landmarks Commission should all review the design criteria prior to the competition and the resulting proposed designs; the City should follow the CEQA process; the Council should have to give final approval to any project before being authorized to proceed; and the public should be involved at every step.

The SJLTC is offering San José the gift of an iconic structure that <u>could</u> be a welcome addition to the city: I truly hope that a properly designed and properly situated gift <u>will</u> be a welcomed icon for the city. This is to be the gift of a lifetime: please involve the public and take the time to assure that it is done right.

The Guadalupe River Park Conservancy (GRPC) is the City's non-profit partner in the development and activation of the Guadalupe River Park and Gardens. Our mission is to accomplish this through education, advocacy, and stewardship and that has been our role for at least the past 30 years. As stewards, we are protective of the ecological resources of the park and gardens. We have organized countless river clean-ups and fought projects that would have resulted in significant impacts to the riparian habitat, our park, and our trail system.

Our mission also directs us to thoughtfully develop, activate, and in some instances, redevelop the park and gardens for existing and future residents, the Downtown workforce, and visitors to San Jose. As Downtown development soars, the park and gardens will be solidified as San Jose's urban Central Park and we are receptive to projects that meet our goals and dovetail with this grand and audacious vision. In recent months, we've been working with SPUR and appreciate their collaborative efforts to forward our collective vision.

The Arena Green area of the Guadalupe River Park is currently developed with tennis courts, trails and pathways, memorials (Vietnam War Memorial), monuments (San Jose Ice Skating Champions), an amphitheater, carousel with ticket building, playgrounds, picnic tables, restrooms, and benches. It is an urban park area adjacent to the confluence of the Los Gatos Creek and the Guadalupe River and their riparian habitats. While we are protective of our ecological resources, we believe that with implementation of a 100-foot riparian corridor setback as defined by the City of San Jose's Riparian Corridor Policy, a "landmark" or "monument" can be constructed within Arena Green in an environmentally sensitive manner. In addition, with our plans to move the carousel to our wildly successful Rotary Children's PlayGarden along Coleman Avenue, there may be an opportunity for the landmark project to occupy what will become an area to redevelop in Arena Green.

As there is no design yet and an Ideas Competition is being completed, it will be the Conservancy's role to ensure that whatever is considered is respectful of and complementary to our ecological resources and respects our vision and the

environment. As they say, "the proof will be in the pudding" and we will require and the San Jose Light Tower Corporation has agreed to consult with us and give us a seat on the selection jury during project selection activities. We will require that the project be consistent with the Conservancy's vision and that it be sensitive to the habitat values of both Los Gatos Creek and the Guadalupe River. We will require and the Light Tower Corporation has agreed to work hand-in-hand with the Conservancy during all phases of the project.

The Conservancy is encouraged that biological resources and lighting have been evaluated in advance of the Ideas Competition. This early information allows for the project to be designed with mitigation measures actually incorporated into the project – a "Mitigate by Design" approach. We are hopeful that this approach will significantly reduce or avoid impacts to the riparian habitat and wildlife species. Again, we will be actively involved in the project design process and will require that the project be sensitive to the environment and that legally defensible CEQA documents be completed.

In closing, the Board of Directors of the Guadalupe River Park Conservancy supports the visioning process on which the Light Tower Corporation is about to embark. With a design that further activates Arena Green and is sensitive to the riparian habitat and wildlife species of Los Gatos Creek and the Guadalupe River, we feel it could be a place-making amenity.
