



**MINUTES OF THE
JOINT MEETING OF THE RULES AND OPEN GOVERNMENT COMMITTEE
AND COMMITTEE OF THE WHOLE**

SAN JOSE, CALIFORNIA

WEDNESDAY, FEBRUARY 27, 2019

The Joint Meeting of the Rules and Open Government Committee and Committee of the Whole of the City of San José convened in Regular Session at 2:00 p.m. in Council Chambers.

Documents Filed: Memorandum from Vice Mayor Chappie Jones, dated February 21, 2019, recommending retroactive approval of a City Council sponsored Special Event.

Public Comment: Blair Beekman shared his enjoyment of the February 15 event.

Action: Upon motion by Councilmember Johnny Khamis, seconded by Vice Mayor Chappie Jones and carried unanimously, approval of the City Council sponsored Special Event was accepted and placed on March 12, 2019 City Council Agenda for action.

2. Gun Violence Prevention (Mayor/Jones)

Direct the City Manager and City Attorney to revise and update sections of Chapter 10.32 of the San José Municipal Code (“Firearms Sales”) to:

1. Require of all licensees of vendor permits:

a) Video and Audio Recording Transactions: Video- and audio-record every firearm and ammunition transfer to any unsworn member of the public, provide adequate storage of that data for a minimum period, and enable reproduction or access to the videos to SJPD or other agency designated by the City Manager upon request;

(b) Training: Train all staff within a year of ordinance implementation and all new hires within 3 months of implementation, to question potential purchasers, within earshot of the audio recording device, to determine whether the customer seeks to purchase the gun or ammunition for themselves, or for another person (“straw purchaser”). The questions shall comply with a checklist or protocol published by the San José Police Department, in consultation with the City Attorney;

(c) Inventory Checks: Perform at least one annual inventory check, and immediately report any missing or stolen firearms and/or ammunition to SJPD;

(d) Suicide Prevention: Display information at point of-sale about local gun laws, suicide warning signs, and Santa Clara County-approved resources for suicide prevention and domestic violence.

2. Prohibit the sale of any firearms and ammunition within or from a residence.

3. Modernize section 10.32.030-requiring a license for sale, transfer, or advertisement of concealable firearms-to include the regulation of sale of all firearms, ammunition, and downloadable firearms within the city.

(a) If proposed state legislation in this session fails to address the 3D-printed gun loophole, direct the City Attorney to specifically include language that extends the requirements of SJMC Section 10.32 to anyone who provides or downloads data required for the production of a 3D-printed firearm or its components.

2. Gun Violence Prevention (Cont'd.)

Documents Filed: (1) Joint memorandum from Mayor Sam Liccardo and Vice Mayor Chappie Jones, dated February 19, 2019, recommending revision of Sections of Chapter 10.32 of the Municipal Code. (2) "Council Policy Early Consideration Response Form", sponsored by Mayor Sam Liccardo, dated February 25, 2019. (3) Letter from Giffords Law Center, dated February 5, 2019, offering support to the proposed amendment. (4) Email correspondence from Lawrence Ashley Townsend, dated February 24, 2019, Ron Romanow, dated February 25, 2019, and Wallace Gardner, dated February 27, 2019, offering opposition to the proposed amendment. (5) Email correspondence from Portia Mather-Hempler and from Connie Cunningham, both dated February 26, 2019, expressing support to the proposed amendment.

Public Comments: Expressing support to the gun violence prevention proposal were Katy Wilkinson, Teresa Fiss and Sharon Genkin (Moms Demand Action); Andrew Boone, Erik Swanson and Steve Jacobs. Expressing opposition to the proposal, citing an infringement of civil rights, were Stephen Monfort, Vince Moudry, Wallace Gardner and Lawrence Townsend. Dave Truslow advocated for investigating applicants that lie on their form 4473.

Councilmember Johnny Khamis expressed reservations with the amendments as proposed and recommended a deferral of this item pending further input by law enforcement officials.

Action: Upon motion by Vice Mayor Chappie Jones, seconded by Councilmember Sylvia Arenas, and carried, the City Manager and City Attorney were directed to revise and update sections of Chapter 10.32 of the San José Municipal Code, as outlined in the joint memorandum from Mayor Sam Liccardo and Vice Mayor Chappie Jones, dated February 19, 2019, including preparation of a draft resolution, with the exception of Item #3, which will be introduced at a later date. The remainder of this item will return to Council by the end of the fiscal year. (4-1. Noes: Khamis.)

3. Age and Family Friendly City Initiative (Arenas)

- 1. Modify the name of the "Age Friendly City Initiative" to the "Age and Family Friendly City Initiative."**
- 2. Integrate into the "Age and Family Friendly Initiative" current and relevant items in the Neighborhood Services and Education Committee work plan.**
- 3. At the next Quarterly Legislative Update, bring forward to Council an update to the "Family Friendly Legislation" policy position to read "Age and Family Friendly Legislation" and include it in the list of top city-wide legislative priorities. Also, include updates on legislative efforts that focus on children and families.**
- 4. Include in the "Age and Family Friendly City Initiative" other relevant prioritization items that the Council adopts, as well as the implementation of existing human resources city policies.**

3. Age and Family Friendly City Initiative (Cont'd.)

Documents Filed: (1) Memorandum from Councilmember Sylvia Arenas, dated February 21, 2019, providing recommendations regarding the Age and Family Friendly City Initiative. (2) "Council Policy Early Consideration Response Form", sponsored by Councilmember Sylvia Arenas, dated February 26, 2019. (3) Letter from Laura Arechiga, TOCKNA President, dated February 27, 2019, offering support to Councilmember Arenas' recommendations.

Public Comments:

1. Andrew Boone agreed on the need for special accommodations for children and seniors.
2. Wendy Guraboo (First 5 Santa Clara County) thanked Arenas for her vision.
3. Blair Beekman brought up the need to address other issues such as youth crime.

Mayor Sam Liccardo questioned if the name change will pose a problem for procuring grants since the designation is different. Chief of Staff, Office of the City Manager, Lee Wilcox responded, and discussion followed. Concerns were shared on a potential loss of focus on the senior program.

Action: Upon motion by Councilmember Sylvia Arenas, seconded by Vice Mayor Chappie Jones and carried unanimously, recommendations as outlined in Councilmember Sylvia Arenas' memorandum dated February 21, 2019, providing recommendations regarding the Age and Family Friendly City Initiative, were accepted. (5-0.)
