BACKGROUND

The City Council will interview applicants for the San José Board of Fair Campaign and Political Practices ("BFCPP," formerly Ethics Commission) to fill any vacancies.

This office routinely reviews applications to City Boards, Commissions and Committees. Although the applications do not provide complete information, they do occasionally disclose potential conflicts of interest or incompatible offices. The purpose of this memorandum is to highlight major areas of potential conflict that are disclosed by the applications. In order to analyze potential conflicts, it is necessary to consider the duties of the particular commission or committee to which the applicant is seeking appointment.

DUTIES

The BFCPP is a five-member commission established to:

- Monitor compliance with all campaign, lobbying and ethics ordinances in the San José Municipal Code (See SJMC Title 12);
- Investigate complaints and issue findings where appropriate, including fines; and
- Recommend changes to campaign, lobbying, and ethics regulations and policies.

MEMBERSHIP REQUIREMENTS

BFCPP members must be appointed by a two-thirds vote of the City Council and selected by the same procedure of application and public interview used for the Planning Commission. (SJMC § 2.08.1610.) BFCPP members may also be removed by two-thirds vote of the City Council for any reason or no reason. (SJMC § 2.08.1640.)

BFCPP members must have some demonstrated familiarity and experience with campaign laws and should be representative of the community. (SJMC § 2.08.1630(A).) They also have special eligibility requirements, which may result in a vacancy or removal if not followed. (SJMC § 2.08.1630, see also SJMC § 2.08.050.) BFCPP members must be qualified electors of the City and may not hold elected public office; publicly endorse any candidate for City office; engage in political or campaign activity on

behalf of any candidate for City office; or be employed by or have any contractual relationship with any candidate for City office. (SJMC § 2.08.1630(A)(C)(E)(F).) Further, no member can participate as a candidate in any election for public office for a period of one year before and after tenure on the Board. (SJMC §§ 2.08.1630(D).) Finally, no member may be employed by the City or have any direct and substantial financial interest in any business, work or official action taken by the City. (SJMC §§ 2.08.1630(B).)

APPLICANTS

Brandon Eisenberg – Mr. Eisenberg is employed as a paralegal with the law firm Shea & Shea. His spouse is also employed with Shea & Shea. Mr. Eisenberg's application does not disclose any apparent conflicts of interest or incompatible offices.

<u>Adrian Gonzales</u> – Mr. Gonzales has served on the BFCPP since 2015 and has been Chair since 2017. He is employed as an Advisory Manager with Macias, Gini & O'Connell. Macias, Gini & O'Connell does provide services for the City, but there is no indication that Mr. Gonzales has a direct or substantial financial interest in the specific work Macias Gini & O'Connell performs for the City. Accordingly, Mr. Gonzales's application does not disclose any apparent conflicts of interest or incompatible offices.

<u>Joe Lopez</u> – Mr. Lopez is a retired Deputy Sheriff/Sergeant with the Santa Clara County Sheriff's Department. His spouse is currently employed with the Santa Clara County Department of In-Home Supportive Services (IHSS).

Mr. Lopez currently serves as the president of the National Latino Peace Officers Association (NLPOA). This role could create an eligibility issue for Mr. Lopez while serving on the BFCPP if he participates in political activity for a candidate for city office on behalf of the NLPOA. Under SJMC 2.08.1630.E, "while serving on the [BFCPP], no member will publicly endorse any candidate for city office nor engage in any political or campaign activity on behalf of any candidate for city office."

Otherwise, Mr. Lopez's application does not disclose any other apparent conflicts of interest or incompatible offices.

<u>Kerstyn Olsen</u> – Ms. Olsen is currently unemployed but previously worked for Ripple as a Legal Compliance Intern. Ms. Olsen is also J.D. Candidate at Santa Clara University School of Law. Ms. Olsen's application does not disclose any apparent conflicts of interest or incompatible offices.

<u>Peter Searles</u>– Mr. Searles is currently a student at De Anza Community College. His spouse is employed with Seagate Technology, Inc. as Corporate Counsel. Mr. Searles states that he is an active member of the Public Banking Action Team of the South Bay Progressive Alliance. This role could create an eligibility issue for Mr. Searles while

serving on the BFCPP if he participates in political activity for a candidate for city office on behalf of the South Bay Progressive Alliance. Under SJMC 2.08.1630.E, "while serving on the [BFCPP], no member will publicly endorse any candidate for city office nor engage in any political or campaign activity on behalf of any candidate for city office."

Otherwise, Mr. Searles's application does not disclose any other apparent conflicts of interest or incompatible offices.

Louis Silver – Mr. Silver is a partner with the law firm Sliver & Katz. Mr. Silver's application does not disclose any apparent conflicts of interest or incompatible offices.

Thomas Skinner – Mr. Skinner is employed as an attorney with Project Sentinal. He is currently a City Commissioner with the Appeals Hearing Board. Under Council Policy 0-4, "no commissioner shall serve on more than one commission at a time. Should a commissioner seek appointment to another commission, upon his/her new appointment, the commissioner shall be deemed automatically resigned from his or her original commission." Therefore, Mr. Skinner will be deemed to have resigned his position on the Appeals Hearing Board if he is appointed to the BFCPP.

Otherwise, Mr. Skinner's application does not disclose any other apparent conflicts of interest or incompatible offices.

<u>Omar Teutle</u> – Mr. Teutle is employed as an investigator with the California Public Utilities Commission (CPUC). His spouse is also employed with the CPUC as a Public Utilities Regulatory Analyst. Mr. Teutle's application does not disclose any apparent conflicts of interest or incompatible offices.

<u>Kathleen Thomas</u> – Ms. Thomas is employed as an Occupational Therapist/Bilingual Intake Coordinator with Via Services. Her spouse is employed as Building Maintenance/Electrician with Western Management LLC. Ms. Thomas's application does not disclose any apparent conflicts of interest or incompatible offices.

<u>Joel Zizmor</u> – Mr. Zizmor is a retired bank auditor, examiner and consultant. His spouse is a retired teacher. Mr. Zizmor's application does not disclose any apparent conflicts of interest or incompatible offices.

CONCLUSION

None of the applicants appear to hold any incompatible offices or to have conflicts of interest that would preclude them from serving on the BFCPP at this time. All applicants have represented on their application that they are a qualified voter of the City to satisfy the criteria under San José Municipal Code section 2.08.1630 to serve on

I have served on the Board of Fair Campaign and Political Practices for the last four years, the last two years serving as the Chair of the Board. In my career, I serve as a government consultant for state and local government agencies in which I've provided consulting services to a range of governing bodies, providing a deeper understanding of how boards and commissions operate.

I have served on the Board of Fair Campaign and Political Practices for the last four years working on a number of policy studies referred by the City Council, two biennial ethics reviews, and numerous enforcement investigations.

The Board is responsible for upholding Title 12 of the Municipal Code which outlines local campaign and ethics laws. As a Board Member I would be responsible for enforcing applicable Title 12 regulations in collaboration with the Board's contracted investigator, as well as making recommendations to the City Council to improve the City's campaign and ethics laws.

Please list three issues facing the City that you feel the Commission should address.

1) Community Engagement - Through the course of serving on the Board the last four years, I've come to find through my contacts in the community that few know about the existence of the Board, our enforcement authority, or that the City has its own ethics laws in Title 12. I'm currently working with the City Clerk's Office to compile outreach materials that summarize the Board's roles and responsibilities and contact information to file complaints to help spread the word through civic organizations. 2) Political Posturing - During the last four years on the Board, I've noticed that some political opponents use the public nature of the Board's investigative process to push negative media coverage without substantive evidence of campaign violations. I'm working with the City Clerk as a part of the biennial ethics review to research how to improve the investigative process to reduce abuse during campaign season. 3) Education - Over the last two years during major elections, I've noticed that several enforcement actions involved entities not knowing about Title 12 and the city's local ethics laws. In conjunction with the community engagement issue, I'm looking to see if engaging with civic organizations and spreading marketing/awareness materials will help mitigate noncompliance with local laws.
