Dear Mayor Liccardo and Councilmembers:

Please reject the San Jose Light Tower proposal to design and donate a landmark on Arena Green. This is not an appropriate site, and the public is already unhappy with the City of San Jose for its willingness to divest itself of public land.

- The limitations of Arena Green indicate that a landmark big enough to show up on the San Jose skyline simply can't be built there. It can't be higher than surrounding buildings due to the approach to Mineta International Airport and the massive Shark Tank next door. It can't be shiny or colorful, or illuminated after dark because of the wildlife corridor of the Guadalupe River Confluence.
- 2. The promoters claim the landmark will "activate" the space in the evenings (presumably like the Sonic Runway did at City Hall Plaza) but this ignores the restriction about lighting at night.
- 3. Arena Green is already a gathering place in daytime, one of only two large spaces suitable for staging runs and walks, rallies after marches from City Hall, or cultural festivals such as the Fantasy Faire. The presence of a large structure (and large construction site) will change the logistics of this site. Even if it technically belongs to the City Park system, it won't be a park with the same public uses.
- 4. The committee did not consult the public until they already had a plan, rather than consulting the public to see what we actually wanted. Better, if less prominent, ideas include: affordable housing, community center, community development resources such as STEM programs for children/teens. an incubator for businesses that don't get VC funding (such as the disadvantaged people served by Kiva), or even San Jose's version of the Ed Roberts Center in Berkeley. That complex brings together all agencies serving disabled people in one building conveniently located at a BART station, instead of requiring multiple trips by paratransit all over San Jose.
- 5. More generally speaking, even upgrading a new Diridon Station to an architectural gem with artistic flourishes would combine form and function as the Grand Central Station of the Northwest. I understand the impatience of elderly donors who want to see the fruits of their funding, but the City should take a longer view.

I understand the City has spent considerable public resources in researching the proposed sites. However, do not fall into the sunk cost fallacy. The logical conclusion of the research is that there is no good site for the proposed landmark, not that we must proceed with a project that will be hamstrung by restrictions of its site.

The idea of donating something impressive to the City of San Jose is worthwhile, but this plan is a bad plan. They need to work with the public to see what the public really wants instead of just

shoving it at us like a too-small ugly Christmas sweater and expecting our gratitude because they put so much work into it. This is more like giving a husky puppy to someone who lives in a high rise and works 80-hour weeks. It would be irresponsible to accept a gift that is incompatible with our living situation.

As a community member who attended the meeting, I can say that the public was unhappy with the project and our concerns were dismissed. Even people who had donated were unhappy that the organizers had changed the project from reconstructing the historic light tower to commissioning an international design project for something new and innovative. They couldn't even communicate this effectively to their own donors, which seems like a bad sign to me.

Please preserve "the front yard of Downtown San Jose", Arena Green.
