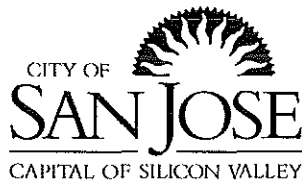
RECOMMENDATION:

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Welch Park community room Grand Re-Opening will be held on March 30, 2019 at Clarice Drive and Kenesta Way and is sponsored by Councilmember Sylvia Arenas. This special event invites the community to come out and explore the newly remodeled room which will house upcoming classes and activities for all ages. The event is free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Sylvia Arenas will report any cash or in-kind donations received
