I don't want to rile people up, but I feel I should have shared more information earlier because I think at least some of those who opposed moving Hope Village to that vacant concrete spot kind of near the Caltrain parking lot had fears that were unfounded.

No one, including me, wants another Jungle. This was never going to be that. All of these folks had been vetted by a Catholic community that worked with them; many were elderly. The village already had facilities for laundry, trash, safe cooking, and so forth. Plus it was very few people and the tents were not random ragged assortments, but looked kind of military and neat.

These were not the kind of people that were going to be loitering around stealing things and causing a ruckus. And it was so close to Sacred Heart Community Services too!

I know that some of the folks on this list really do care about homeless people, and it is possible that some opponents do also. If so, you could help the city and county find alternate sites. One temporary possibility is the OSH area.
