In accordance with Sections 5613 and 5616 of the California Streets and Highways Code, the City's Department of Transportation is further directed to cause to be issued, by postage prepaid mail, not less than seven (7) days nor more than ten (10) days after the mailing of the first notice, and not less than ten (10) days prior to the June 11, 2019 hearing date, a second notice, clearly marked as "SECOND NOTICE", of the cost of repair and date and hour fixed for the public hearing.
