# **RECOMMENDATION**

Adopt the following Fiscal Year 2018-2019 Appropriation Ordinance amendments in the General Fund:

- (a) Increase the City Auditor's Office Non-Personal/Equipment appropriation by \$28,500; and
- (b) Decrease the City Auditor's Personal Services appropriation by \$28,500.

# **OUTCOME**

This action will fund the City Auditor recruitment costs.

#### **BACKGROUND**

The City Auditor is retiring on March 29, 2019, and the Mayor's Office is planning to hire a recruiting firm to conduct the recruitment for the City Auditor position.

## **ANALYSIS**

Due to the City Auditor's pending retirement on March 29, 2019, the Mayor's Office will be coordinating the recruitment and hiring of a new City Auditor. A recruiting firm will be used to conduct the recruitment at an estimated cost of \$28,500. The City Auditor's Office has insufficient funding in its Non-Personal/Equipment budget to cover this expense; however, projected savings in the City Auditor's Personal Services appropriation are available to offset this cost.

As discussed above, there are sufficient Personal Services savings to fund the City Auditor recruitment costs.
