## RECOMMENDATION

- (a) Approve award of a construction contract for the 2019 Americans with Disabilities Act Sidewalk Accessibility Ramps Project (No. 2092), to the low bidder, JJR Construction, Inc. in the amount of \$685,998.
- (b) Approve a 10% contingency in the amount of \$68,600.

#### **OUTCOME**

Approval of this construction contract will facilitate construction and upgrade of approximately 123 sidewalk curb ramps. Approval of a 10% contingency will provide funding for any unanticipated work necessary for the proper construction and completion of the project.

## **BACKGROUND**

The Department of Transportation annually installs new and retrofits existing curb ramps at intersection corners in compliance with the Americans with Disabilities Act (ADA). For this project, approximately 123 curb ramps will be installed or upgraded as part of the City's ongoing ADA sidewalk accessibility program. The locations for new or upgraded curb ramps were generally prioritized and selected based on the following criteria established in the City's 2010 *ADA Transition Plan Update for Sidewalks:* 

**Priority 1:** Known routes used by and requests received by persons with disabilities.

Priority 2: Locations along pedestrian corridors, arterial or collector streets, serving state or local government and public use facilities such as governmental buildings, public hospitals and medical facilities, public housing projects and homeless shelters, police service centers, employment training centers and public schools.

Priority 3: Locations along routes and in proximity to transit stops serving public accommodation facilities, such as private hospitals and medical offices, parks, senior facilities, major shopping malls, major employment sites and supermarkets.

**Priority 4:** Locations associated with other capital improvement projects, such as pavement resurfacing, streetscape improvements and development projects.

**Priority 5:** All other locations within the public right-of-way, including residential and industrial areas.

The infrastructure improvements will provide curb ramps at intersection corners for pedestrians' gradual access as they transition between the different elevations of sidewalk and street pavement, a beneficial feature to constituents with mobility limitations such as seniors, wheelchair-dependent and visually impaired users.

The Attachment contains the list of locations to receive new or upgraded curb ramps by this project. As additional funding becomes available for curb ramp projects, the Department of Transportation will install or upgrade them based on the criteria above.

The low bid submitted by JJR Construction, Inc of \$685,998.00 is 4.9% below the Engineer's Estimate. The Engineer's Estimate of \$721,580.00 is based on bids received from similar past projects and current estimated construction prices. The bid is considered acceptable for the work involved in the project. Staff recommends that the construction contract be awarded to JJR Construction, Inc.

In accordance with Council Policy 1-18, the standard contingency for a street or sidewalk project is 5% of the total contract. Staff is requesting a 10% contingency for this project in the event there is a need for additional sidewalk or/and curb and gutter repair that may arise during construction. The funding budgeted for this project is sufficient to provide for the recommended 10% contingency of \$68,600. Construction is scheduled to begin in May 2019 and will be completed in the Summer of 2019.

#### **EVALUATION AND FOLLOW-UP**

The Department of Transportation provides an ongoing evaluation of the City's pavement and walkway accessibility conditions and provides periodic reports on this topic to the Transportation and Environment Committee. No further City Council action is necessary.

## **PUBLIC OUTREACH**

To solicit contractors, this project was listed on the City's Internet Bid Line and advertised in the *San José Post Record*. Bid packages for this construction project were made available to download for contractor organizations and builders' exchange on the City's Internet Bid Line. In addition, when the project commences, the contractor, as stated in the specifications, will provide advance notification regarding working hours, duration of project, and any appropriate schedule and lane closures to affected businesses and residents. To inform traveling motorists of upcoming construction activities and potential traffic delays, changeable message signs may be
