## Council and Mayor of the City of San José for July 1, 2019-June 30, 2023.

The Commission discussed Council Salaries. Commission Member Eileen Consiglio submitted a copy of a column written by Scott Herold for the Mercury News and published on July 3, 2017. Commission Member David Burckhard submitted his top ten factors to consider when establishing the Councilmember and Mayor salary. Chair Doug Ludlow showed the Commission a spreadsheet he developed to show the ratio of Mayor and Council pay to Cost of Living in the comparable cities. After discussion, the rate for Councilmember salary was set at \$125,000 and the rate for the Mayor's salary was set at \$190,000 with the Chair directed to work with the City Clerk on the letter language and return for final language approval and signature at the next meeting. (Moved: Burckhard Seconded: Consiglio—3-0). The Commission took no action to change the \$200 penalty for the unexcused absence of a Councilmember from a meeting leaving the \$200 in effect.
