**SUBJECT: APPROVAL OF PICNIC WITH PERALEZ SPONSORED BY COUNCIL DISTRICT 3 AS A CITY COUNCIL SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE EVENT**

## RECOMMENDATION

1. Approve the Picnic with Perez event scheduled on June 23, 2019 as a City Council sponsored Special Event and approve the expenditure of funds.
2. Approve and accept donations from various individuals, businesses, or community groups to support the event.
3. Place the item on the May 21, 2019 Council Agenda for action.

## BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Picnic with Perez will be held on June 23, 2019 at the Children's Discovery Museum and sponsored by Councilmember Raul Perez. This special event will bring together community members for an afternoon of food, drinks, and community conversation. Residents attending will learn about district wide updates and upcoming events. This event is hosted by Councilmember Raul Perez, the Children's Discovery Museum and the San Jose Downtown Residents Association. The event is free and open to the public.
