A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE **AUTHORIZING** THE CITY MANAGER DESIGNEE TO: (1) NEGOTIATE AND **EXECUTE** CONCESSION AGREEMENTS (AGREEMENTS) BETWEEN CITY OF SAN JOSE AND RECOMMENDED PROPOSER ENTITIES, SUBJECT TO CERTAIN CONDITIONS. FOR THE CONSTRUCTION AND OPERATION OF FOOD AND BEVERAGE CONCESSIONS NORMAN Y. MINETA SAN INTERNATIONAL AIRPORT (AIRPORT) FOR PACKAGES I, II AND III AS LISTED IN THE FOOD AND BEVERAGE REQUEST FOR PROPOSALS (RFP); (2) NEGOTIATE AND MODIFY THE CONCESSION CONCEPT TYPES, LOCATIONS. AND/OR DESIGNS WITH THE RECOMMENDED PROPOSER ENTITIES, AS NEEDED, TO ALIGN THE CONCEPTS WITH THE NEEDS OF THE AIRPORT; AND (3) TERMINATE NEGOTIATIONS WITH ANY OF THE RECOMMENDED PROPOSERS FOR PACKAGES I. II. OR III. IN THE EVENT THAT CITY AND RECOMMENDED PROPOSERS CANNOT AGREE UPON THE TERMS OF THE AGREEMENTS AND NEGOTIATE AND EXECUTE AGREEMENTS WITH THE HIGHEST-RANKED PROPOSERS, IN ORDER OF THEIR RANKING FOR EACH PACKAGE, UNTIL AN **BEEN REACHED** AGREEMENT HAS WITH AN OPERATOR

WHEREAS, the City of San José ("City") owns and operates the Norman Y. Mineta San José International Airport; and

WHEREAS, on January 4, 2019, City released a Request for Proposal for Food and Beverage Concession Opportunities at the Airport ("RFP"); and

WHEREAS, the RFP was structured into three "Packages" for specific locations of food and beverage concessions; and

WHEREAS, concurrent with the action contemplated herein, Council approved the

selection of the top-ranking proposers for the RFP's Packages I, II, and II; and

WHEREAS, Council desires to authorize the City Manager or designee to:

1. Negotiate and execute Concession Agreement(s) ("Agreements") between City and

certain proposer entities, effective from the date of execution by City Manager

through June 30, 2035; and

2. Negotiate and modify the concept types, locations, and/or designs with the entities

above, as needed, to align the concepts with the needs of the Airport; and

3. Terminate negotiations with any of the recommended proposers for Packages I, II,

or III in the event that City and the recommended proposer(s) cannot agree upon

the terms of the Agreement, and negotiate and execute Agreements with the next

highest-ranked proposers, in order of their ranking for each package, until an

Agreement has been reached with an operator;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN

JOSE THAT:

The City Manager or designee is hereby authorized to:

1. Negotiate and execute Agreements between City and the following entities, effective

from the date of execution by the City Manager through June 30, 2035:

a. SSP America Inc. for the construction and operation of food and beverage

concessions at the Airport listed as Package I of the RFP; and

b. Elevate Gourmet Brands-SJC Group for the construction and operation of a food

and beverage concession at the Airport listed as Package II of the RFP; and

c. WSE Group Inc. for the construction and operation of a food and beverage

concession at the Airport listed as Package III of the RFP.

2. Negotiate and modify the concept type, concept locations, and/or concept designs

with the entities above, as needed, to align the concepts with the needs of the

Airport.

3. Terminate negotiations with any of the recommended proposers for Packages I, II,

or III in the event that City and the recommended proposer(s) cannot agree upon

the terms of the Agreement(s), and negotiate and execute Agreements with the next

highest-ranked proposers, in order of their ranking for each package, until an

Agreement has been reached with an operator.
