#### **RECOMMENDATION**

#### **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Picnic with Peralez will be held on June 23, 2019 at the Children's Discovery Museum and sponsored by Councilmember Raul Peralez. This special event will bring together community members for an afternoon of food, drinks, and community conversation. Residents attending will learn about district wide updates and upcoming events. This event is hosted by Councilmember Raul Peralez, the Children's Discovery Museum and the San Jose Downtown Residents Association. The event is free and open to the public.

#### **ANALYSIS**
