BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Dumpster Days will be held on; May 25, 2019 on San Ignacio Dr. between Curie Dr. and Endmoor Dr.; June 1, 2019 on Poston Dr. between Obert Dr. and Tiffan Dr.; June 15, 2019 on Mat Ave between Lyoncross Wy. and Orchard Park Dr.; and lastly June 22, 2019 on Skyway Dr. between Lyric Ln. and Paloma Ave. These events are sponsored by Councilmember Sergio Jimenez. These special events provide residents with an opportunity to dispose of unwanted items in a safe and secure environment and help curb illegal dumping on city streets. ANALYSIS
