2. 2019-2020 FY Budget Study Session (Peralez, Jimenez, Carrasco, Esparza, Arenas)

<u>Documents Filed</u>: Joint memorandum from Councilmembers Peralez, Jimenez, Carrasco, Esparza and Arenas, dated April 11, 2019, recommending incorporation of an Equity Fund discussion into the Council Study Session on the 2019-2020 Budget.

<u>Public Comments</u>: Expressing support to the creation of an equity fund and the need for determination of resources and program and equitable access to services in the City's diverse communities, were: Martha O'Connell, Omar Vasquez, Glenna Howcroft, Jeffrey Buchanan, Will Smith, Andrew Boone, Patricia Gardner, Flor DeLeon, Dilza Gonzalez and Victor Vasquez.

Councilmember Raul Peralez, Councilmember Maya Esparza and Councilmember Sylvia Arenas offered examples of how the underserved members of communities in San José may benefit from an equity fund and spoke to the merits of evaluating opportunities and addressing disparities in the City's priorities.

Mayor Sam Liccardo offered input and proposed creation of an MBA that will more closely identify what services would have to be cut to advance this idea. City Manager, David Sykes offered comments on how to focus into these priorities. Committee discussion ensued.

<u>Action</u>: Upon motion by Councilmember Sylvia Arenas, seconded by Vice Mayor Chappie Jones and carried unanimously, the City Manager was directed to incorporate the following into the Council Study Session on the 2019-2020 Budget:

- A. Creation of an Equity Fund which would support the equitable distribution of City resources and services and bridge the gap between the City's under-resourced, diverse communities and prosperous neighborhoods.
- B. Explore the possibility of funding the Equity Fund through the Marijuana Business Tax, the Construction Excise Tax or other unrestricted sources, and;
- C. Explore opportunities for bringing an equity lens when determining resources, programming and access to neighborhood services in diverse communities throughout the City.

I. Open Government

1. Appeals of Public Records Act Request – None.

Councilmember Dev Davis left the meeting at approximately 3:52 p.m.

J. Open Forum

- 1. Martha O'Connell expressed concerns about divisiveness and political rhetoric, including concerns regarding a recent appointment to the Planning Commission
- 2. Omar Vasquez asked that an independent investigation be initiated into the killing of Jennifer Vasquez, and that the officers' body cams be released. He additionally noted the need for more patrolling and police officers in his neighborhood, and expressed dissatisfaction with the decision of the 6-5 vote on yesterday's mayoral ballot issue.
- 3. Andrew Boone articulated disappointment in the outcome of the mayoral ballot issue. He also advocated for "Open Forum" to be heard at the beginning of the City's meetings.
- 4. Flor DeLeon expressed disagreement with representation on the Planning Commission and opined that it does not adequately represent the needs of our community.
