(1) Verbal Report on Economic Development Activities. (Economic Development).

<u>Documents Filed</u>: Provide a brief summary of recent announcements, significant accomplishments, and upcoming events related to economic development.

Deputy City Manager Kim Walesh presented highlights of the latest edition of the SJ Economy E newsletter, including: launch of The Kickstarter Platform - a crowd funded system that allows entrepreneurs and people worldwide to fundraise for projects and investments, which, according to the Brookings Institution, raked a combined \$16M in eight years for 82 projects in San Jose; an article on a successful tour of downtown organized by the San Jose Downtown Association Real Estate Tour 2018, wherein four buses took 170 people on old and new view of the City; ribbon cutting for phase 1 at the Assembly at North First – the rehabilitated former Lam Research Campus signaling the availability of more than 1 million square feet of leasable space; a celebration of Webcore Construction's latest office opening in downtown San José at One Almaden; and OED's collaboration with SAGE or (Sustainable Agricultural Education) on efforts to support agriculture-based businesses in San Jose, among other features.
