ANALYSIS

The Mayor and the City Manager are responsible for developing the City Council Meeting Schedule. To facilitate more efficient planning of longer range agenda content, the Administration is recommending approval of a meeting schedule for the entire 2019-2020 fiscal year, rather than the past practice of approving only the next six-month cycle (Attachment A). The Administration also recommends the continuance of the established practice of cancellation of Council meetings when there is a holiday that falls on a Monday.

Additionally, at the request of the Rules & Open Government Committee, the Administration has developed a tentative schedule of Study Session dates (Attachment B) to facilitate calendaring for Council Members and the Mayor. Staff will continue to develop the Council's study session interests into planning for upcoming topics. As topics are set for the dates in the attachment, staff will bring these forward to the Rules and Open Government Committee for approval.
