**WHEREAS**, the San José Municipal Code ("Code") authorizes the Council to declare City-owned real property surplus to the needs of the City and to authorize the sale or exchange of such surplus property; and

**WHEREAS**, Section 4.20.080 of the Code authorizes the City Council to convey any surplus City-owned property to any other governmental or public agency; and

WHEREAS, the City negotiated the sale of the Properties directly with Santa Clara Valley Water District ("SCVWD"), in the amount of \$445,000, which represents the fair market value of the Properties; and

**WHEREAS**, the City will retain Public Road Easement, Public Service Easement and Public Sidewalk Easement across the Properties; and
