**A RESOLUTION OF THE COUNCIL OF THE
CITY OF SAN JOSE SETTING SCHEDULES
OF STORM SEWER SERVICE CHARGES FOR
FISCAL YEAR 2019 - 2020, AND
SUPERSEDING RESOLUTION NO. 78617**

WHEREAS, Part 6 of Chapter 15.16 of Title 15 of the San José Municipal Code authorizes the setting of storm sewer service charges by resolution of the City and Council, and the collection of such charges for the purpose of deriving revenue for acquisition, repair, rehabilitation, construction, reconstruction, operation and maintenance of the storm sewer system of the City of San José; and

WHEREAS, between April 21, 2011 and April 29, 2011, public notices were mailed to property owners in the City advising them that on June 14, 2011, the San José City Council would be holding a public hearing to consider a storm sewer service rate increase for FY 2011-2012 and authorization for up to one additional rate increase in FY 2012-2013 on July 1, 2012; and

WHEREAS, there was no protest by a majority of affected property owners to the storm sewer service charge rate increase; and

WHEREAS, on June 14, 2011, the Council adopted Resolution No. 75857 setting schedules of Sanitary Sewer Service and Use Charges and Storm Sewer Service Charges for Fiscal Year 2011-2012; and

WHEREAS, on August 7, 2012, the Council adopted Resolution No. 76382, which Resolution maintained the same storm sewer service charges as adopted in Fiscal Year 2011-2012 for Fiscal Year 2012-2013; and

WHEREAS, on June 18, 2013, the Council adopted Resolution No. 76676, which Resolution maintained the same storm sewer service charges as adopted in Fiscal Years 2011-2012 and 2012-2013 for Fiscal Year 2013-2014; and

WHEREAS, on June 10, 2014, the Council adopted Resolution No. 77013, which Resolution maintained the same storm sewer service charges as adopted in Fiscal Years 2011-2012, 2012-2013 and 2013-2014 for Fiscal Year 2014-2015; and

WHEREAS, on June 23, 2015, the Council adopted Resolution No. 77463, which Resolution maintained the same storm sewer service charges as adopted in Fiscal Years 2011-2012, 2012-2013, 2013-2014, and 2014-2015 for Fiscal Year 2015-2016; and

WHEREAS, on June 14, 2016, the Council adopted Resolution No. 77779, which Resolution maintained the same storm sewer services charges as adopted in Fiscal Years 2011-2012, 2012-2013, 2013-2014, 2014-2015, and 2015-2016 for Fiscal Year 2016-2017; and

WHEREAS, on June 13, 2017, the Council adopted Resolution No. 78205, which Resolution maintained the same storm sewer services charges as adopted in Fiscal Years 2011-2012, 2012-2013, 2013-2014, 2014-2015, 2015-2016 and 2016-2017 for Fiscal Year 2017-2018; and

WHEREAS, on June 5, 2018, the Council adopted Resolution No. 78617, which Resolution maintained the same storm sewer services charges as adopted in Fiscal Years 2011-2012, 2012-2013, 2013-2014, 2014-2015, 2015-2016, 2016-2017 and 2017-2018 for Fiscal Year 2018-2019; and

WHEREAS, the Council wishes to maintain the same storm sewer service charges as adopted in Fiscal Years 2011-2012, 2012-2013, 2013-2014, 2014-2015, 2015-2016, 2016-2017, 2017-2018 and 2018-2019 for Fiscal Year 2019-2020;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE:

SECTION 1. Schedule of Storm Sewer Service Charges.

For all premises connected directly or indirectly to or served by the storm sewer system, storm sewer service charges are hereby established for Fiscal Year 2019-2020 for the premises listed below:

A.	Single-family residential and duplex, if connected to the system prior to July 1, 2019	\$94.44 per year
	Single family residential and duplex, if connected to the system on or after July 1, 2019	\$7.87 per month
B.	Mobile Home Residential, per unit, if connected to the system prior to July 1, 2019	\$47.28 per year
	Mobile Home Residential, per unit, if connected to the system on or after July 1, 2019	\$3.94 per month
C.	Residential Condominium, per unit, if connected to the system prior to July 1, 2019	\$51.60 per year
	Residential Condominium, per unit, if connected to the system on or after July 1, 2019	\$4.30 per month
D.	Large Multiple Family Residential (5 or more units), per unit, if connected to the system prior to July 1, 2019	\$51.60 per year
	Large Multiple Family Residential (5 or more units), per unit, if connected to the system on or after July 1, 2019	\$4.30 per month

E.	Small Multiple Family Residential (3-4 units), if connected to the system prior to July 1, 2019	\$179.40 per year
	Small Multiple Family Residential (3-4 units), if connected to the system on or after July 1, 2019	\$14.95 per month
F.	Open Space, annual charge if connected to the system prior to July 1, 2019	\$166.32 -PLUS- \$92.04 per acre
	Open Space, monthly charge if connected to the system on or after July 1, 2019	\$13.86 -PLUS- \$7.67 per acre
G.	School, annual charge if connected to the system prior to July 1, 2019	\$166.32 -PLUS- \$45.72 per acre
	School, monthly charge if connected to the system on or after July 1, 2019	\$13.86 -PLUS- \$3.81 per acre
H.	Church, annual charge if connected to the system prior to July 1, 2019	\$332.76 -PLUS- \$92.04 per acre
