SUBJECT: RETROACTIVE APPROVAL OF THE CADWALLADER DUMPSTER DAY SPONSORED BY COUNCIL DISTRICT 8 AS A CITY COUNCIL SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE EVENT

## **RECOMMENDATION**

- 1. Retroactively approve the Cadwallader Dumpster Day scheduled on March 30, 2019 as a City Council sponsored Special Event and approve the expenditure of funds.
- 2. Retroactively approve and accept donations from various individuals, businesses or community groups to support the event.
- 3. Place the item on the June 18, 2019 Council Agenda for action.

#### **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Cadwallader Dumpster Day was held on March 30, 2019 at the Cabana Club on San Felipe and was sponsored by Councilmember Sylvia Arenas. This special event invited community members to discard unwanted items free of charge. The event was free and open to the public.

#### **ANALYSIS**

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Sylvia Arenas will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 8, City departments and the Office of the City Clerk to proceed with
