A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE TO SET A PUBLIC HEARING TO APPROVE THE PLACEMENT OF THE 2019-2020 ANNUAL SANITARY SEWER SERVICE AND USE CHARGE AND STORM SEWER SERVICE CHARGE ASSESSMENTS ON THE 2019-2020 SANTA CLARA SECURED PROPERTY TAX ROLL; DIRECT THE DIRECTOR OF FINANCE TO FILE THE 2019-2020 SANITARY SEWER SERVICE AND USE CHARGES REPORT ON OR BEFORE JULY 15, 2019; AND DIRECT THE CITY CLERK TO PUBLISH A NOTICE OF THE FILING OF THE SANITARY SEWER SERVICE AND USE CHARGES AND STORM SEWER SERVICE CHARGES REPORTS, AND THE TIME AND PLACE OF THE PUBLIC HEARING

WHEREAS, Section 15.12.550 of the San José Municipal Code requires the Director of Finance to file a report each year with the City Clerk, on or before July 5, or such other date or dates as the City Council may specify by resolution, regarding Sanitary Sewer Service and Use Charges (“SSSUC”), and requires the City Clerk to cause notice of filing of the report issued by the Director of Finance regarding the imposition of annual SSSUC, and the time and place of the public hearing; and

WHEREAS, Section 15.16.1410 of the San José Municipal Code requires the Director of Finance to file a report each year with the City Clerk, at least fifteen (15) days before the public hearing on the Storm Sewer Service Charge (“SSSC”) assessments, and requires the City Clerk to cause notice of filing of the report issued by the Director of Finance regarding the imposition of annual SSSC, and the time and place of the public hearing; and

WHEREAS, City staff recommends that the filing date for the Director of Finance’s annual report for Fiscal Year 2019-2020 SSSUC be moved from July 5, 2019 to July

15, 2019 in order to allow staff the time necessary to provide the most complete, accurate and current listing of the Fiscal Year 2019-2020 SSSUC and SSSC;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT:

1. Tuesday, August 6, 2019 at 1:30 p.m., or as soon thereafter as the matter may be heard, in the Council Chambers of the City of San José, City Hall, located at 200 East Santa Clara Street, San José, California, is hereby fixed as the time and place for the public hearing to approve the placement of the 2019-2020 annual Sanitary Sewer Service and Use Charge and Storm Sewer Service Charge assessments on the 2019-2020 Santa Clara County Secured Property Tax Roll based upon the annual Sanitary Sewer Service and Use Charge and Storm Sewer Service Charge reports of the Director of Finance;
2. The Director of Finance is hereby directed to file the Fiscal Year 2019-2020 annual Sanitary Sewer Service and Use Charge report with the City Clerk on or before July 15, 2019 instead of July 5, 2019; and
3. The City Clerk is hereby directed to publish notice of the filing of the Director's reports, and the time and place of the Public Hearing.
