# **RECOMMENDATION**

Adopt a resolution authorizing the City Manager to execute the Sixth Amendment to the Agreement for the Purchase and Installation of a Public Address System with Signature Technologies, Inc. dba Com-Net Software to extend maintenance and support services for up to three additional one-year options through July 14, 2022 and increase compensation in the amount of \$121,927 for July 15, 2019 through July 14, 2020, for a not-to-exceed maximum compensation of \$4,425,722 through July 14, 2020, subject to the appropriation of funds.

## **OUTCOME**

Provide ongoing support and maintenance to ensure optimal operation of the public address system (System) utilized throughout the Norman Y. Mineta San José International Airport (Airport) to page passengers and issue public announcements.

## **BACKGROUND**

Signature Technologies, Inc. dba Com-Net Software (Com-Net) was selected through a Request for Proposal process conducted in 2007 to provide and implement a public address system at the Airport. In March 2008, the San José City Council authorized the Director of Finance to execute a seven-year agreement with Com-Net, inclusive of four one-year options to extend the term through July 14, 2014. Since that time, Council has approved four additional Council actions related to expanding and updating the System as new terminals and gates get added and

extending the term of Agreement<sup>2</sup> by adding additional options. The last option on the Agreement ends July 14, 2019.

## **ANALYSIS**

The public address system is an integral part of the passenger experience at the Airport and provides timely and vital information to the traveling public. The System is made up of a complex set of technologies that have been enhanced and tuned over the past 10 years but is now nearing end of life and must be replaced.

Staff plans to issue a Request for Proposal for a replacement System within the next 12 months. There are a number of newer technological alternatives now available. However, the current System must be maintained and operational until a new System is in place. Deployment of a new System is expected to take up to 12 months. Approval of the recommendations in this memo would allow ongoing maintenance and support of the existing System until a new solution has been procured and implemented.

## **EVALUATION AND FOLLOW-UP**

This memorandum will not require any follow-up from staff.
