I deem it critical for every representative body to include a wide variety of perspectives, values, backgrounds, and experiences. To my understanding, the City's boards and commissions are tasked with serving and representing the interest of the public at large by gathering and analyzing public input. Therefore it is of the upmost importance that to the extent possible, every community is represented within the various boards and commissions in order to elevate issues and narratives that may otherwise go unidentified and unaddressed. As a young black immigrant woman, I rarely see representation of women of color and in particular, black women, in positions of leadership. This means that often times issues concerning my community are often not amongst mainstream discourse, which evidently fails to empower us. Moreover, as a recent graduate, many of my peers are quite disenfranchised with all forms of government, as government is perceived to not well represent the concerns and interests of young people. Likewise, I see very few young people involved in their local governments, or any level of government. As someone who identifies with various segments of the population who are not often included in the dialogue pertaining to public and communal interest, I would really love the opportunity to step up and to be a voice to my generation, to women of color, and to immigrants, as these voices often go unheard and it's high time we all play our part in further integrating these voices into any discourse regarding public interest. One of my main passions pertains to girls and women's rights and empowerment, and I am wholeheartedly inspired by the role that girls and women can play as change agents and equal contributors to the economic, social, and cultural fabric of their communities. I did a lot of work with anti-sexual assault initiatives in college, while serving as a member of the Student and Presidential Committee on Sexual Assault, as a Sexual Assault Peer Advocate who underwent rigorous training to be a direct resource for anyone who had experienced sexual assault, dating violence, stalking, or harassment, and needed a confidential place for them to process their feelings, talk about their options, understand their rights, and feel empowered to make decisions that feel right to them. While in college, I also interned at the National Organization for Women where I developed and launched a college campus activist toolkit that would provide hundreds of campus leaders with resources on how to foster a safer and more welcoming college community for every member. Upon my relocation to the Bay Area, I joined the Board of Directors for an organization called About-Face, which seeks to arm arm girls with the knowledge and tools they need to fight back against a culture that diminishes and disempowers them. I also joined the Board of Directors for an organization called Next Door Solutions to Domestic Violence, a nonprofit that offers innovative prevention and intervention services pertaining to domestic violence. As such, I would want to elevate these specific issues within my role as a member--combatting violence against women, and trying to foster a safer city.

I've always been quite passionate about learning and leadership. My earliest form of leadership was when I was high school and I had the wonderful privilege of serving on the Mayor's Youth Council (MYC) for the City of Boston. MYC connects youth who are committed to improving their communities to civic participation in government. Similar to the responsibilities of the county's boards and commissions, MYC was also tasked with representing the interests of the public, in this case the "public" being Boston

youths. I really enjoyed my experience working with the Mayor's Office and having the opportunity to solicit feedback from young members of my community and relaying these to the Mayor's Office, and have the voices of my community represented. I believe that 10 years later, as a 23 year old, I am yet again faced with the incredible opportunity of representing the concerns and interests of a community that I have been living in for nearly two years. 

BACKGROUND

The City Attorney's Office routinely reviews applications to City Boards and Commissions. The applications generally do not provide complete information regarding potential conflicts; however, they do occasionally disclose potential conflicts of interest or incompatible offices. The purpose of this memorandum is to highlight areas of potential conflict which are disclosed by the application. In order to analyze potential conflicts, it is necessary to consider the duties of the particular commission for which the applicant is seeking appointment. This review is limited to the information provided on the applications and is not intended to be comprehensive investigation of potential conflicts involving the applicants.

COMMISSION DUTIES

The Senior Citizens' Commission is responsible for studying, reviewing, evaluating and making recommendations to the Council on matters affecting elderly people in the City.

LEGAL CONFLICTS THAT MAY PRECLUDE VOTE OR PARTICIPATION

Certain positions may preclude a commissioner from participating in a commission discussion or from voting if a matter involving the entity comes before the commission. While this list is not complete, these types of conflicts generally fall within one or more of the following situations:

- An application shows entities that are "sources of income" to a potential commissioner within the 12 months preceding the start of the commission term, as defined under the Political Reform Act,
- An application shows sources of income to a Spouse or Domestic Partner of a potential commissioner within the 12 months preceding the start of the commission term,
- An applicant or the Spouse or Domestic Partner of an applicant, is an Officer or Board Member of an entity and it is foreseeable that the entity could be involved in a matter coming before the commission.

CONFLICTS OF INTEREST

BACKGROUND

This office routinely reviews applications to City Boards, Commissions, and Committees. Although these applications do not offer complete information, they occasionally disclose potential conflicts of interest or incompatible offices. This memorandum highlights major areas of potential conflict disclosed in the applications. However, this review is limited to the information provided, and is not intended to be a comprehensive investigation of potential conflicts involving the applicants.

COMMISSION DUTIES

The Neighborhoods Commission is an advisory body to the City Council. (SJMC §§ 2.08.3400 *et seq.*) It studies, reviews, evaluates, and makes recommendations to the City Council "regarding issues, policies, and programs affecting the quality of life in San José neighborhoods, focusing on neighborhood safety, transportation, and code enforcement." (SJMC § 2.08.3430.) In addition, it serves as a Citizens' Oversight Board that reports to the City Council about revenue expenditures generated from the November 2016 voter-approved sales tax. (Reso. No. 78016.)

COMMISSION MEMBERSHIP

The Commission is a 20-member body with 2 members from each Council district. Each member must reside within the boundaries of the council district for the seat to which he or she was appointed during the term of that seat. (SJMC §§ 2.08.3410, 2.08.3420.) If a member is no longer a resident of the council district, the seat will be deemed vacant.

The City Council appoints Neighborhoods Commissioners after taking into consideration nominations provided through a neighborhood groups caucus process. (SJMC § 2.08.3440.A.) If a vacancy occurs outside of the scheduled caucus process, the Council may fill the vacancy based on the recommendation of the council appointment advisory

commission. (SJMC § 2.08.3440.D.)

LEGAL CONFLICTS THAT MAY PRECLUDE VOTE OR PARTICIPATION

Certain positions may preclude a commissioner from participating in a commission discussion or from voting on a matter if there is a conflict. While this list is not complete, conflicts usually fall within the following situations:

- An application shows entities that are "sources of income" to a potential commissioner within the 12 months preceding the start of the commission term, as defined under the Political Reform Act.
- An application shows sources of income to a spouse or Domestic Partner of a potential commissioner within the 12 months preceding the start of the commission term.
- An applicant or the spouse or Domestic Partner of an applicant, is an Officer
 or Board Member of an entity and it is foreseeable that the entity could be
 involved in a matter coming before the commission.

In each of these instances, the commissioner may be required to recuse himself or herself if a matter comes before the Commission affecting the above interests.

APPEARANCE OF BIAS

There may also be facts which would not amount to a legal conflict of interest, but still require recusal because certain relationships may create an appearance of bias. City Council policy requires commissioners to be free from bias in their decision-making and may require recusal if the facts could reasonably lead one to conclude that the commissioner would be biased for or against an entity or entities.

CANDIDATES FOR COUNCIL DISTRICT 4

<u>Barinder Ahluwalia</u>: Applicant submitted his application on Apr 04, 2019. He states that he resides in District 4 and is retired. He also states that he serves as a commissioner for the Santa Clara County Roads Commission.

No incompatible offices or conflicts are disclosed.

Afia Laiq: Applicant submitted her application on November 10, 2018. Applicant states that she resides in District 4, and that she is employed by Chevron, as a Scrum Master/Manager, and her spouse is employed with Align Technologies.

Applicant also states that she serves as the Vice President of the Sixth District PTA, which is made up of 221 school PTA's, and that she is the President of the North Valley Council of PTA's, which compromises 16 PTA's and three School Districts in San José. It is possible that the Commission could consider an issue that may come within the purview of her leadership role in these groups, presenting an actual conflict or appearance of bias. In such a case, Applicant may need to recuse herself from taking part in the Commission's decision on that matter.

Otherwise, no incompatible offices or conflicts of interest are disclosed.

CONCLUSION

The Council may wish to consider the above comments in making appointments to the Neighborhoods Commission. Presently, applicants do not appear to have any disclosed incompatible offices or conflicts that would prevent serving on the Commission.

BACKGROUND

This Office routinely reviews applications to City boards and commissions. The applications generally do not provide complete information; however, they do occasionally disclose potential conflicts of interest or incompatible offices. The purpose of this memorandum is to highlight major areas of potential conflict which are disclosed by the applications.

COMMISSION DUTIES

The Human Services Commission was formed to study, review and evaluate, and make recommendations to the City Council regarding programs and matters affecting human rights. The membership of the Commission is to be representative of the entire community and is to be comprised of persons with human rights concerns. At least one (1) member of the Commission is required to be a disability service provider or representative of the disabled community. At least one (1) other Commissioner is required to be a domestic violence service provider or survivor.

APPLICANTS

Applications from the applicants listed below were reviewed by our office. This review was limited to the information provided on the applications and was not intended to be comprehensive investigation of potential conflicts involving the applicants. Unless otherwise indicated, no application discloses incompatible offices or apparent conflicts of interest that would substantially impair the functioning of the commission.

APPEARANCE OF BIAS

There may be facts which would not amount to a legal conflict of interest <u>requiring</u> a commissioner to recuse him or herself from a commission vote or discussion, however the relationship could create an appearance of bias on the part of the commissioner. City Council policy requires commissions to be free from bias in their decision making, and may require a commissioner to recuse him or herself if the facts could reasonably lead one to conclude that the applicant would be biased for or against an entity or entities.

LEGAL REVIEW OF APPLICANTS

Set forth below are the applicants and any apparent legal conflicts of interest and/or appearance of bias related to entities that are likely to come before the Commission in some manner, as identified in their applications.

<u>Bill Strahm</u> – Mr. Strahm's application indicates he is employed as a SAE at Xilinx. The application does not indicate a spouse. His application discloses neither incompatible offices nor apparent conflicts of interest.

<u>Hassan Sabbagh</u> - Mr. Sabbagh's application indicates he is employed by Home Net 123 as Owner. The application does not indicate a spouse. His application discloses neither incompatible offices nor apparent conflicts of interest.

<u>Adrian Rafizadeh</u> – Mr. Rafizadeh's application indicates he is an intern with the office of the City Clerk for the City of San Jose. [There is no issue with respect to this internship because it was completed on or about August 3, 2018.] The application indicates no spouse. His application discloses neither incompatible offices nor apparent conflicts of interest.

<u>Cherise Orange</u> – Ms. Orange's application indicates she is employed by the County of Santa Clara as an Associate Planner. The application does not indicate a spouse. The application indicates she is Chair of the Board for the African American Community Service Agency in San Jose. If Ms. Orange is appointed to the Commission, there could be a conflict of interest necessitating recusal of Ms. Orange, or potentially of the Commission, if an item comes before the Commission that involves the African American Community Service Agency. Other than that, her application discloses neither incompatible offices nor apparent conflicts of interest.

Adaeze Nduaguba – Ms. Nduaguba's application indicates she is employed by Google LLC as a Legal Assistant. The application does not indicate a spouse. Her application indicates she is a Board member for Next Door Solutions to Domestic Violance; About Face; and Silicon Valley Young Democrats. If Ms. Nduaguba is appointed to the Commission, there could be a conflict of interest necessitating recusal of Ms. Nduaguba, or potentially of the Commission, if an item comes before the Commission that involves Next Door Solutions to Domestic Violence, About Face, or Silicon Valley Young Democrats. Other than that, her application discloses neither incompatible offices nor apparent conflicts of interest.

<u>Peter Nanopoulos</u> - Mr. Nanopoulos' application indicates he is employed by Planned Parenthood as a NextGen Technical Specialist/Trainer. The application indicates his spouse is employed by GNC as a sales representative. His application discloses neither incompatible offices nor apparent conflicts of interest.

<u>Ashley Johnston</u> – Ms. Johnston's application indicates she is employed by Creative Blue as a Project Manager. The application does not indicate a spouse. The application discloses neither incompatible offices nor apparent conflicts of interest.

<u>Tracy Jacobs</u> – Ms. Jacobs' application indicates she is a retired from the City of San Jose where she was employed as a receptionist. The application does not indicate a spouse. Her application indicates she is an Ambassador for Atria (registers new residents to vote). The application discloses neither incompatible offices nor apparent conflicts of interest.

<u>Christine Fitzgerald</u> – Ms. Fitzgerald's application indicates she is employed by Silicon Valley Independent Living Center as a Community Advocate. The application does not indicate a spouse. Her application indicates she is vice-chair for VTA's Committee on Transportation and Mobility Access. The application discloses neither incompatible offices nor apparent conflicts of interest.

<u>Mohua Chatterjee</u> – Ms. Chatterjee's application indicates she is unemployed and her spouse is employed by Snaproute as a software engineer. Her application discloses neither incompatible offices nor apparent conflicts of interest.

CONCLUSION

The applicants do not appear to have any incompatible offices or pervasive conflicts which would prevent them from serving on the Commission; although two applicants may be precluded from participating in matters involving entities on which they serve as board members. You may wish to consider the above comments in appointing the applicants to serve on the Human Services Commission.
