What can the Airport do to balance its obligations as a "good neighbor" and as a worldclass international airport for Silicon Valley? If there is a conflict in achieving an appropriate balance, how would you resolve it?

The Bay Area has some of the most complex airspace in the United States, with challenges similar to JFK, EWR (Newark) and LGA (LaGuardia) in the New York Area. That complexity limits many options to alter arrivals and departures at one airport without creating an impact on the other two airports in the Bay Area. With Next Gen (Satellite based) Air Transportation System we have seen improvements in on-time performance and fuel economy but we have also seen severe impacts on communities, as flights arrive and depart on much narrower flight paths, creating additional noise concerns. To resolve this issue the three bay area airports, along with elected and appointed officials need to continue to work closely with the FAA to find realistic solutions. We simply cannot move noise from one community to another. However, I believe through collaboration of all parties we can assist in facilitating the dialog, and I am willing to work towards that end. Dialog will create understanding which will then equate to realistic solutions.

What can the City of San José and the Airport do to engage Silicon Valley business leaders and other communities to support the Airport's efforts to increase air service and add routes to SJC? What can you do personally to help achieve this goal?

The business and community leaders I've spoken to would be thrilled to see more flight availability at Mineta San Jose International Airport. Those of us that fly do not particularly care for a 45-minute drive to San Francisco International Airport. Therefore, I believe there is already business and community support for this endeavor. Having said that, I believe that inviting business and community leaders to meet on the topic could provide the commission and the City of San Jose valuable insight, and guite possible a collaborative game plan. In order for this to be effective, we should not forget to engage airlines industry and ask them to be a part of this process. I would be willing meet with other airports to learn how they have successfully brought airlines and services to their airports for their communities, engage with both business and community leaders, and be an active part of this collaborative effort for San Jose: There will always be challenges when working to create a world-class international airport. Being a "good neighbor" requires us to improve the connection between businesses and resident affected by airport operations. I have always found that communication and addressing challenges (which I like to call "opportunities"), head on is the best. By engaging residents and business representatives we can foster dialog and strengthen relationships. Relationship building translates to greater understanding and a closer connection, but most importantly, it hopefully provides an opportunity for action before a challenge becomes a full-blown problem. That action translates into goodwill among stakeholders. If there is a conflict in achieving an appropriate balance, how would you resolve it? Through collaboration! Collaborating requires a high degree of cooperation and assertiveness. However it also allows for the very best creative solution that probably could not have been accomplished through a single individual or side in a conflict.
