City Manager's Chief of Staff Lee Wilcox, Emergency Management Director Raymond Riordan, Emergency Planner Aurelia Bailey, and Emergency Coordinator Ann Tran gave updated activities related to improving City readiness to the reported hazards, and responded to questions.

Emergency Management Director Raymond Riordan provided the basis for the activities, strategies and plans for which the city must prepare for 13 natural hazards, 11 technology hazards, nine terrorism threats as well as nine intentional threats, including prioritized risk assessment threats based off the probability and impact of earthquake, severe weather and flooding, dam and levee failure as well as landslide, wildfire, and drought.

2. 18-1749 Role of the Elected Officials Training.

Staff will present a combined curriculum from the Federal Emergency Management Agency (ICS402-Elected Officials Overview) and California Office of Emergency Services (Elected Officials Guide) to describe the Elected Officials Responsibilities. By the end of this session, Council members will:

- Understand their role before, during and after an emergency.
- Understand the purpose of a Disaster District Office Understand the next step for Disaster District Office planning
