RECOMMENDATION

1. Retroactively approve the Beauty Spot's Annual School Supply Drive scheduled on Saturday, August 10, 2019 as a City Council sponsored Special Event and approve the expenditure of funds.
2. Approve and accept donations from various individuals, businesses or community groups to support the event.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Annual School Supply Drive was held on Saturday, August 10, 2019 at The Beauty Spot and sponsored by Councilmember Arenas. This special event is an annual school supply drive for free haircuts for kids and all school supply donations benefited a local elementary school. The event was free and open to the public.

ANALYSIS
