A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE APPROVING VEGGIELUTION'S APPLICATION FOR A COUNTY OF SANTA CLARA HISTORIC GRANT FOR THE NON-PERMANENT EDUCATIONAL INTERPRETIVE DISPLAYS PROJECT IN AND AROUND THE ORCHARD, FARM FIELDS, AND GREENHOUSES AT EMMA PRUSCH DELEGATING AUTHORITY TO AN FARM PARK: AUTHORIZED REPRESENTATIVE TO SIGN AND SUBMIT THE GRANT APPLICATION TO THE COUNTY OF SANTA CLARA: SIGN THE GRANT AGREEMENT AND ADMINISTER THE PROJECT ON BEHALF OF VEGGIELUTION: AND. COMMITTING THE PROJECT PROPERTY TO THE PROJECT USE FOR A PERIOD OF AT LEAST TWENTY YEARS

WHEREAS, the County of Santa Clara ("County") has established the Historic Grant Program to acknowledge and celebrate untold perspectives of underrepresented communities within Santa Clara County ("Grant Program"); and

WHEREAS, the County funds the Grant Program; and

WHEREAS, Veggielution, a non-profit that farms about one-acre at Emma Prusch Farm Park that provides healthy sustainable food for the community (the "Applicant") submitted a Grant Application to the County in order to seek Grant Program funds for the following Project: to add non-permanent educational interpretive displays in and around the orchard, farm fields, and greenhouses at Emma Prusch Farm Park (the "PROJECT"); and

**WHEREAS**, the PROJECT will help expand the prevailing historical narrative for agriculture in Santa Clara County as the "Valley of Heart's Delight"; the displays will highlight untold stories of Asian immigrant farmers and their contributions to the success of agriculture in Santa Clara County; and

WHEREAS, the PROJECT will be located at 647 South King Road in San Jose. California (the "Property"), and said Property is owned or controlled by the City of San José (the "Property Holder"); and

**WHEREAS**, City has reviewed the grant application submitted by Veggielution and, if the project receives funding, the terms of the grant require the Applicant to provide for continual public use of the Project on a non-discriminatory basis for 10 years and will allow for, or provide, the continued maintenance of the project for 10 years.

**WHEREAS**, the City is granting permission (consent) to the Applicant to use the Property for the PROJECT for the period of time ("Term") set out in the Grant Application, and said consent is evidenced by this resolution); and

**NOW, THEREFORE, BE IT RESOLVED that the City of San José hereby makes the** following determination:

1. If the Applicant is awarded the grant, the PROJECT is located on the Property that will be continually used for the PROJECT for the Term as set out in the Grant Application.
