RECOMMENDATION

1. Retroactively approve the Housing Forum event scheduled on August 26, 2019 as a City Council sponsored Special Event and approve the expenditure of funds.

2. Approve and accept donations from various individuals, businesses, or community groups to support the event.

3. Place the item on the September 17, 2019 City Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Housing Forum event was held on August 26, 2019 at the Berryessa Community Center and sponsored by Councilmember Lan Diep. Councilmember Diep had a conversation with Housing Director Jackie Morales-Ferrand regarding housing and homelessness. This provided an opportunity for District 4 residents to know more about San José's housing situation, what challenges it faces, and what the City is doing to address all issues related to housing.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Diep will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 4, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
