Dear Councilmember Esparza,

I am writing to request your full consideration and decision to discontinue the Safe Parking for Families Pilot Program at the Tuesday, September 10, 2019 city council meeting. I am the current President of the Franklin-McKinley School District Board of Trustees and represent myself in this role and as a constituent of San Jose City Council District 7.

As President of the Board of Trustees, it is a high priority that we maintain and remember the safety of our children who attend our schools. The Safe Parking Pilot Program is in obvious conflict with the safety of our children as the participants have not been fully vetted to make certain that there are on registered child predators parking in the designated lot adjacent to our two schools. It is clear that the Housing Department staff failed to completely research the implications of this program being placed next to schools. I expressed my concerns and objection to this program at a meeting with the housing department leadership as a representative of the school district, yet, they failed to include the district's concerns in their presentation.

No where in the Housing Department's presentation is there mention of children at two schools adjacent to this pilot program's parking lot. While the Franklin-McKinley School District expressed concerns a meeting in City Hall with the Housing Department leadership and Councilmember Esparza, the staff has failed to note the concerns in the presentation about the safety of the children attending both schools (Kipp and Los Arboles). This is a clear omission and I am obligated to note this prior to your decision to discontinue the Safe Parking Pilot Program.

Included in Councilmember Maya Esparza's memorandum:

"Accept staff's recommendation to discontinue the Safe Parking For Families Pilot Program at Seven Trees Community Center and transition families to a motel voucher program.

Our support for staff's recommendation to discontinue the Pilot Program at Seven Trees and transition to a motel voucher program is based upon the program results, feedback and discussion with the community, the Franklin-McKinley School District, and the desires of the families themselves.

At a community meeting in May, both the Franklin-McKinley superintendent and the President of the Franklin-McKinley School Board voiced their opposition to continuation of the program, a position echoed by the other community members in attendance."

To Mayor Sam Liccardo and Councilmembers of the City of San Jose:

I am submitting this letter on behalf of our Franklin-McKinley School District community, specifically the Seven Trees community that we serve. I have been present at the community meetings that the city staff has held and there has been overwhelming opposition to the Safe Parking program. Every time I visit the school, the parents have approached me with their concerns and the impact that the program has had and what they witness as they are walking their children to and from school.

There are many reasons to support services for our most vulnerable residents that are struggling with homelessness. However, I am writing to express my opposition to the proposed plan to keep the program directly across from our elementary school that will now serve single adults. I want to support the Memo by Councilmember Esparza to Agenda Item 5.1 for tomorrow's city council meeting. I strongly urge the City Council to explore alternate locations that are not directly across two schools serving 900+ children. Los Arboles Elementary serves children between the ages of 4 and 8 and KIPP Charter School serves children between the ages of 11 and 14.

Again, while I fully support the need for additional housing and services for those facing homelessness, I do not support the current location of this program given the impact that it has had on the overall community and our students and families. I agree that families are better off transitioning to Motel Vouchers. The school district has a long history of providing services and partnering with various organizations that support youth, families and individuals facing homelessness, including Catholic Charities of Santa Clara County and Amigos de Guadalupe. We will continue to extend our support to help those experiencing homelessness.

If the city is going to consider changing the program from serving families to serving single adults, then the Housing Department staff should conduct community meetings before the council makes this decision. The Housing Department's work load and lack of capacity to conduct community outreach should not be the reasons the city does not solicit input from the community on the proposed change to the program or to find an alternate location.

I would have delivered this message in person but unfortunately our board meeting is scheduled at the same time when the city council will be hearing this agenda item.
